Your Committee on Health, to which was referred S.B. No. 2337
entitled:

"A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION TO THE
DEPARTMENT OF HEALTH FOR THE ADULT MENTAL HEALTH DIVISION,"

begs leave to report as follows:

The purpose of this measure is to authorize an increase in
the expenditure ceiling of the Mental Health and Substance Abuse
Special fund by an emergency appropriation for the adult mental
health division.

Your Committee received testimony in support of this measure
from the Department of Health, Hawaii Disability Rights Center,
Hawaii Medical Association, and Mental Health Association in
Hawaii.


Your Committee finds that an emergency appropriation is
needed to ensure that the Hawaii state hospital can meet its
obligations for providing adult mental health services and to
implement additional services in compliance with the settlement
agreement in *United States v. State of Hawaii*, Civil Number.
91-00137 (DAE KSC).

Committee on Health that is attached to this report, your
Committee is in accord with the intent and purpose of S.B.
No. 2337 and recommends that it pass Second Reading and be
referred to the Committee on Ways and Means.
