Your Committee on Health, to which was referred S.B. No. 2373  
entitled:

"A BILL FOR AN ACT RELATING TO CONTROLLED SUBSTANCES,"

begs leave to report as follows:

The purpose of this measure is to make conforming amendments  
to a provision of the Uniform Controlled Substances Act (UCSA) to  
make it consistent with Act 193, Session Laws of Hawaii 2005.

Your Committee received testimony in support of this measure  
from the Department of Public Safety and the Attorney General.

Act 193 added three new sections to the UCSA, which placed  
additional restrictions on the sale of over-the-counter  
pseudoephedrine products. The proposed statutory amendments  
clarify that the "sale, transfer, furnishing, or receipt" of  
pseudoephedrine or norpseudoephedrine fall under the purview of Act  
193.

As affirmed by the record of votes of the members of your  
Committee on Health that is attached to this report, your  
Committee is in accord with the intent and purpose of S.B.  
No. 2373 and recommends that it pass Second Reading and be  
referred to the Committee on Judiciary and Hawaiian Affairs.
