Your Committee on Health, to which was referred S.B. No. 3152
entitled:

"A BILL FOR AN ACT MAKING AN APPROPRIATION FOR THE HANA
COMMUNITY HEALTH CENTER,"

begs leave to report as follows:

The purpose of this measure is to appropriate funds to the
Hana Community Health Center to allow it to continue its current
level of operations and further develop its capacity to meet the
on going needs of this isolated community.

Your Committee received testimony in support of this measure
from the Hana Community Health Center and nine individuals.

Your Committee finds that the mission of the Hana Health
Community Center to improve the health and wellness of the
district of Hana is especially beneficial to the residents who are
underserved due to financial, cultural, or geographic barriers.
Your Committee further finds that funding for the Center will
enable it to continue improving the social and economic conditions
of the fragile community.

Your Committee has amended this measure by omitting the
provisions for equipment and commercial kitchen equipment, thus
reducing the amount appropriated to \$1,052,780.
