Your Committee on Health, to which was referred S.C.R.
No. 206 entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE JUDICIARY TO
ESTABLISH AN APPROPRIATE FEE FOR COURT-ORDERED FORENSIC
EVALUATIONS AND TO PROVIDE COPIES OF THE EXAMINATION REPORTS
TO THE DEPARTMENT OF HEALTH,"

begs leave to report as follows:

The purpose of this measure is to request the Judiciary to
establish an appropriate fee for court-ordered forensic
evaluations and to provide copies of the examination reports to
the Department of Health.

Your Committee received testimony in support of this measure
from the Hawaii Government Employees Association, and the Hawaii
Disability Rights Center. The Judiciary submitted comments to
this measure. Your Committee received testimony in opposition to
the measure from the Department of Health.

Your Committee finds that requesting the Judiciary to
establish appropriate fees for forensic evaluations and to provide
the Department of Health with copies of these evaluation reports
will streamline the forensic evaluation process for pretrial
detainees.

Your Committee has amended this measure in response to the
testimony submitted by the Department of Health by eliminating
superfluous language.
