HB 2315 (HSCR258-06)	RELATING TO THE CODE OF FINANCIAL INSTITUTIONS. Eliminates obsolete requirements and improves the procedures for the licensing and regulation of financial institutions by the Division of Financial Institutions.	CPH, WAM
HB 1021 HD2 (HSCR861-06)	RELATING TO PUBLIC UTILITIES. Increases PUC commissioners' salary. Authorizes PUC chairperson to appoint utility analysts and legal assistants exempt from chapter 76. Authorizes the PUC to suspend collection of public utility fees when balance of PUC special fund exceeds \$3,000,000. (HB1021 HD2)	CPH, WAM
HB 2717 HD1 (HSCR908-06)	RELATING TO THE PUBLIC UTILITIES COMMISSION. Creates a selection commission to pick members of the Public Utilities Commission. Establishes terms of service. (HB2717 HD1)	CPH, WAM
HB 3118 HD1 (HSCR717-06)	RELATING TO CORPORATIONS. Authorizes the incorporation of companies under the proposed Responsible Business Corporation Act for corporations that consider the public's interest in doing business. (HB3118 HD1)	CPH, WAM
HB 2368 HD2 (HSCR839-06)	RELATING TO PUBLIC HOUSING. Makes permanent the streamlined public housing eviction process. Exempts families with children, disabled individuals, and the elderly. (HB2368 HD2)	CPH, JHW
HB 105 HD1 (HSCR832-06)	RELATING TO THE RESIDENTIAL LANDLORD-TENANT CODE. Prohibits tenants or guests from unlawfully possessing dangerous, harmful, or detrimental drugs in a dwelling unit or on surrounding premises. Authorizes a summary eviction proceeding for violation of the prohibition, wherein the landlord may rely upon notices or reports issued by law enforcement. (HB105 HD1)	CPH, JHW



HB 1800 RELATING TO SALE OF REAL PROPERTY. CPH, WAM
HD1 Increases the tax on the disposition of real property by a non-resident
(HSCR824-06) seller (HB1800 HD1).

HB 1796 RELATING TO NOTICE. CPH, JHW
HD1 Requires that in counties with a population of less than 200,000, the
(HSCR638-06) public notice of foreclosure on a mortgaged property located in the
county shall be published at least three times, two of which must be in
a newspaper published in and having the largest circulation in the
county (HB1796 HD1).
