| SB 1294 | RELATING TO PUBLIC LAND TRUST REVENUES.<br>Allocates a portion of public land trust revenues to the repair and maintenance of the Royal Mausoleum. Establishes that the allocation of public land trust revenues is not to be taken from existing pro rata share of revenues reserved for the benefit of native Hawaiians.  | JHW, WAM |
| SB 2424 | RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS.<br>Deletes the requirement for a comprehensive master plan in Chapter 10, HRS, and replaces it with the office of Hawaiian affairs strategic plan.  | JHW      |
| SB 2948 | RELATING TO THE PUBLIC LAND TRUST.<br>Appropriates funds to satisfy the State's obligation to pay the office of Hawaiian affairs its pro rata share of revenues derived from the public land trust.   | JHW, WAM |
| SB 2935 | AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS FOR THE DEPARTMENT OF HAWAIIAN HOME LANDS AND MAKING AN APPROPRIATION.<br>Authorizes the issuance of general obligation bonds to fund the building of a Hawaiian community center facility in Kapolei by the department of Hawaiian home lands.  | JHW, WAM |
| SB 3119 | RELATING TO HAWAIIAN HOME LANDS.<br>Allows the Hawaiian homes commission to deposit moneys in depositories other than the state treasury. Authorizes the Hawaiian homes commission to manage, invest, and reinvest moneys in the trust fund. Authorizes the commission to hold, purchase, sell, assign, transfer, or dispose of any securities and investments and any proceeds from investments in which trust fund moneys have been invested. | JHW, WAM |
| SB 2932 | RELATING TO THE COURTS.<br>Requires that the circuit and district courts be open to conduct judicial business during extended hours. Appropriates funds.  | JHW, WAM |

| SB 2947 | RELATING TO CORRECTIONS.<br>Establishes criteria for contracts with respect to the transfer of inmates to out-of-state correctional facilities.  | JHW, WAM |
| SB 2949 | RELATING TO PUBLIC SAFETY.<br>Creates an office of the ombudsman for prisons and probation to be administratively attached to DPS to investigate prisoner complaints, deaths, and riots.   | JHW, WAM |
| SB 2600 | RELATING TO ELECTRONIC COURT RECORDS, DOCUMENTS, PROCESSES, AND CERTIFICATES.<br>Clarifies that court process records or documents may be created, retained and stored electronically and converted to electronic form; clarifies the requirements for court seals; and allows court documents and records to be electronically signed and sealed. | JHW      |
| SB 2603 | RELATING TO MOTOR VEHICLE INSURANCE.<br>Provides district court judges with discretion to impose a term of imprisonment for first offenses of motor vehicle insurance laws.  | JHW      |
