SB 2546	RELATING TO ECONOMIC DEVELOPMENT. Establishes a task force to study the feasibility of establishing a Hawaii construction authority.	LBR/BED/TGO, WAM
SB 2209	RELATING TO PUBLIC WORKS. Requires DLIR to enforce the laws of chapter 104 and the collection and maintenance of the certified copies of all payrolls.	LBR/TGO, WAM
SB 2303	RELATING TO VETERANS' SERVICES. Authorizes the Governor, as the appointing authority, to set salary of the Director of the Office of Veterans' Services at an amount not exceeding 74% of the salary of the Director of Human Resources Development.	LBR/TGO, WAM
SB 2302	RELATING TO CIVIL DEFENSE AGENCY. Increase the vice-director's salary.	LBR/TGO, WAM




