HB 2503 HD2 (HSCR797-06)	RELATING TO DERELICT VEHICLE. Removes the condition that a vehicle be ten years old or older to be considered "derelict", and updates references to the "housing and community development corporation of Hawaii" with the "Hawaii public housing administration". (HB2503 HD2)	TGO/IGA
HB 1809 HD2 (HSCR719-06)	RELATING TO MOTOR VEHICLE DRIVER'S LICENSE. Allows member of U.S. armed forces on active service outside of Hawaii to renew driver's license within 90 days of the member's return to Hawaii or discharge from hospitalization. (HB1809 HD2)	TGO/IGA, EDM
HB 1825 HD1 (HSCR147-06)	RELATING TO TRAFFIC INFRACTIONS. Amends section 291D-10, HRS, so that unpaid parking citations remain the responsibility of the person who owned the vehicle at the time the citation was issued, even if the vehicle is later transferred or repossessed by a lien holder. Permits the driver's license of the person who was the registered owner at the time the citation was issued to be restricted until outstanding assessments are paid. (HB1825 HD1)	TGO/IGA, JHW
HB 2404 HD1 (HSCR655-06)	RELATING TO PUBLIC MEETINGS. Allows two or more members of a board, but less than the number of members that would constitute a quorum, to discuss their individual positions relating to official board business at meetings of other boards or at public hearings of the Legislature, and to attend and participate in discussions at presentations, including seminars, conventions, and community meetings, that include matters relating to official business. (HB2404 HD1)	TGO/IGA, JHW



HB 2737 HD1 (HSCR686-06)	RELATING TO THE HONOPOU DISTRICT OF THE COUNTY OF MAUI. Requires the attorney general to assist in resolving ownership issues relating to Honopou road, including Honopou bridge, of the Honopou district in Maui County; requires the department of transportation to determine the costs of strengthening Honopou bridge to allow firetrucks to safely cross and reach area residents. (HB2737 HD1)	TGO/IGA, JHW
HB 3037 HD1 (HSCR838-06)	RELATING TO DRIVER LICENSING. Provides that information be made available to a driver's license examiner which pertains to persons under the age of eighteen who have pending violations or proceedings that could result in the suspension or revocation of a driver's license or any pending adjudication for offenses relating to the operation of a motor vehicle. (HB3037 HD1)	TGO/IGA, JHW
HB 1819 HD1 (HSCR696-06)	RELATING TO CHAPTER 281, HAWAII REVISED STATUTES. Corrects various inconsistencies and erroneous references in sections 281-35, 281-41, and 281-94, HRS, relating to intoxicating liquor. (HB1819 HD1)	IGA/TGO, JHW
HB 2637 HD1 (HSCR735-06)	RELATING TO TRANSPORTATION. Provides temporary reprieve from lease and permit requirements for airport vendors who want to make improvements (HB2637 HD1).	TGO, WAM


