A BILL FOR AN ACT

RELATING TO THE MUSEUM OF HAWAIIAN MUSIC AND DANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the economic 1 viability of Hawaii's tourism industry is heavily dependent upon 2 Hawaiian culture. The culture of the indigenous people is 3 unique and of critical importance in differentiating Hawaii from 4 other visitor destinations. Tourism promotions, particularly 5 through media such as music and dance, have relied upon Hawaiian 6 culture as the number one marketing tool and as the foundation 7 for perpetuating the spirit of aloha that is vital to the 8 9 economic success of the industry. The National Academy of 10 Recording Arts and Sciences has recently added the new category 11 of best Hawaiian Music Album to the prestigious Grammy Awards, 12 thereby creating new audiences for Hawaiian music around the 13 world.

14 The legislature further finds that the history of Hawaiian 15 music and dance demonstrates a proud statement of cultural 16 identity. A compilation of collective works and related 17 memorabilia of exceptional individuals who are highly regarded

in their respective fields of endeavor will act to preserve and
perpetuate the Hawaiian culture, as well as to promote
appreciation for these art forms for present and future
generations.

The purpose of this Act is to establish a museum of 5 Hawaiian music and dance committee to determine the appropriate 6 type of institution that should be established, its location, 7 and possible financing mechanisms, and to complete an initial 8 business plan for the museum of Hawaiian music and dance. 9 SECTION 2. (a) There is established a museum of Hawaiian 10 music and dance committee that shall consist of thirteen members 11 and shall include: 12 13 (1)The executive director of the Hawaii tourism 14 authority, or the director's designated

15 representative;

16 (2) A representative from each of the following:

17 (A) The state foundation on culture and the arts;

18 (B) The office of Hawaiian affairs;

(C) Kamehameha Schools;

1 (3) Three members appointed by the president of the 2 senate; provided that the three members appointed by the president of the senate shall include at least two 3 practitioners or former practitioners of the arts of Hawaiian music or dance, and at least one member of 5 the Hawaiian Academy of Recording Artists or a kumu 6 7 hula; and Three members appointed by the speaker of the house of 8 (4) 9 representatives; provided that the three members 10 appointed by the speaker of the house of 11 representatives shall include at least two 12 practitioners or former practitioners of the arts of 13 Hawaiian music or dance, and at least one member of 14 the Hawaiian Academy of Recording Artists or a kumu 15 hula. 16 The committee shall be chaired by the executive (b) 17

17 director of the state foundation on culture and the arts, or the 18 executive director's designated representative; provided that 19 costs of the administrative support for the committee shall be 20 shared equally by the Hawaii tourism authority, the state 21 foundation on culture and the arts, the office of Hawaiian

affairs, and shall be partially funded through a legislative 1 2 appropriation. 3 (c) The committee shall investigate and determine: (1)The type of institution that would be appropriate for 4 a museum of Hawaiian music and dance; 5 (2)The best location or locations for this museum or 6 7 museums; A plan to incorporate the existing Hawaiian Music Hall 8 (3)9 of Fame and Museum into a museum of Hawaiian music and dance; 10 The creation of a Hawaiian dance hall of fame to be (4) 11 12 incorporated into a museum of Hawaiian music and dance; and 13 Possible financing mechanisms for these facilities. 14 (5) The committee shall also complete an initial business plan 15 16 for the museum of Hawaiian music and dance. 17 The committee shall cease to exist on June 30, 2008. (d) SECTION 3. (a) The committee shall submit a report of its 18 19 findings and recommendations to the legislature no later than 20 twenty days prior to the convening of the regular session of 21 2008.

| 14 | tourism authority for the purposes of this Act. |
| 15 | SECTION 5. This Act shall take effect on July 1, 2007. |
