# A BILL FOR AN ACT

RELATING TO DAM SAFETY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 179D, Hawaii Revised Statutes, is
- 2 amended by adding a new part to be appropriately designated and
- 3 to read as follows:
- 4 "PART . DAM AND RESERVOIR SAFETY
- 5 §179D-A Certificate of approval to impound. No owner of a
- 6 dam or reservoir shall impound water without a valid certificate
- 7 of approval to impound water at the dam or reservoir.
- 8 §179D-B Entry upon property. (a) The department shall
- 9 have the right to direct and conduct investigations as it may
- 10 reasonably deem necessary to carry out its duties as prescribed
- 11 in this part. For this purpose, the agents or employees of the
- 12 department or any authorized representatives may enter at
- 13 reasonable times, without prior notice, any property, public or
- 14 private, for the purpose of investigating the condition,
- 15 construction, or operation of any dam, reservoir, or other
- 16 artificial barrier dealt with in this chapter; provided that if
- 17 an emergency situation arises as determined by the department,

- 1 the agents or employees of the department, or any authorized
- 2 representatives shall have the right to enter without prior
- 3 notice, any property, public or private, for the purpose of
- 4 investigating the condition, construction, or operation of any
- 5 dam, reservoir, or other artificial barrier subject to this
- 6 chapter, and to take any remedial actions, without a search
- 7 warrant or liability for trespass.
- 8 (b) It shall be unlawful for any person to refuse entry or
- 9 access to any authorized representative of the department who
- 10 requests entry for purposes of inspection and who presents
- 11 appropriate credentials. It shall also be unlawful to obstruct,
- 12 hamper, or interfere with any representative while in the
- 13 process of carrying out the representative's official duties.
- 14 (c) Notwithstanding any other provision of law to the
- 15 contrary, the board and its agents, engineers, and other
- 16 employees, for the purposes of enforcing this chapter, may enter
- 17 upon any land or water in the state that is the subject of an
- 18 inspection, investigation, or remedial actions without a search
- 19 warrant or liability for trespass.
- 20 §179D-C Injunctive relief. Whenever in the judgment of
- 21 the department any person has engaged in or is about to engage
- 22 in any act or practice that constitutes or will constitute an

- 1 unlawful action under this chapter, the department may apply to
- 2 the circuit court of the county in which the unlawful act or
- 3 practice has been or is about to be engaged in, or in which
- 4 jurisdiction is appropriate, for an order enjoining the act or
- 5 practice, or for an order requiring compliance with this
- 6 chapter. Upon a showing by the department that a person has
- 7 engaged in or is about to engage in any unlawful act or
- 8 practice, a permanent or temporary injunction, restraining
- 9 order, or other order shall be granted without the necessity of
- 10 showing lack of an adequate remedy at law.
- 11 §179D-D Emergency actions. (a) If, in the opinion of the
- 12 department, conditions of any dam or reservoir are so dangerous
- 13 to the health and safety of life or property as to not permit
- 14 time for issuance and enforcement of an order relative to
- 15 construction, modification, maintenance, or repair of the dam or
- 16 reservoir, or the dam or reservoir is threatened by any large
- 17 flood or other natural disaster, the department may immediately
- 18 employ remedial measures necessary to protect life and property.
- (b) The department shall provide coordination and
- 20 assistance to the proper state or county agency or agencies to
- 21 maintain control of any dam or reservoir that, pursuant to
- 22 subsection (a), has been determined to be dangerous to life or

- 1 property until the dam or reservoir is deemed safe, or until any
- 2 emergency conditions that precipitated taking control of the dam
- 3 or reservoir, pursuant to subsection (a), have been abated. The
- 4 department may determine the proper time at which to relinquish
- 5 control of the dam or reservoir.
- 6 (c) Any necessary and reasonable costs and expenses
- 7 incurred by the department in fulfilling the duties mandated by
- 8 subsections (a) and (b) in connection with a remedial or
- 9 emergency action shall be recoverable by the department from the
- 10 owner of any dangerous or threatened dam or reservoir.
- 11 (d) Any owner failing or refusing, after written notice
- 12 has been given, to pay the reasonable costs and expenses
- 13 incurred by the department pursuant to subsection (c) shall be,
- 14 upon complaint by the department to the attorney general,
- 15 subject to reasonable attorney fees incurred in the recovery of
- 16 the costs and expenses.
- (e) All moneys collected by the department pursuant to
- 18 subsection (c) shall be credited to the dam and reservoir safety
- 19 special fund created in section 179D-E.
- 20 (f) If a condition arises that in the opinion of the
- 21 department may pose a danger to the health and safety of persons
- 22 or property and sufficient time permits, the board may issue

- 1 orders reciting the existence of the condition and require any
- 2 actions the board deems necessary. Any person to whom an order
- 3 is directed, may challenge the order, but shall immediately
- 4 comply with the order, pending disposition of the person's
- 5 challenge. The board shall give precedence to a hearing on the
- 6 challenge over all other pending matters.
- 7 (g) The legislature finds and declares that emergency
- 8 actions under this section are in the public interest and for
- 9 the public health, safety, and general welfare of the state, and
- 10 authorizes the board to take any necessary actions.
- 11 §179D-E Establishment of dam and reservoir safety special
- 12 fund. (a) There is established in the department a special
- 13 fund, to be designated the dam and reservoir safety special
- 14 fund. The fund shall be administered by the board. The
- 15 following shall be deposited into the dam and reservoir safety
- 16 special fund:
- 17 (1) Appropriations by the legislature;
- 18 (2) All fees and administrative charges collected under
- 19 this chapter or any rule adopted thereunder;
- 20 (3) Moneys collected as fines or penalties imposed under
- 21 this chapter or any rule adopted thereunder;

1	(4)	Moneys derived from public or private sources to
2		benefit dam and reservoir safety;
3	(5)	Moneys collected in full or partial satisfaction of
4	N.	liens created under this chapter;
5	(6)	Any moneys collected from the sale of retail items by
6		the department relating to dam and reservoir safety;
7	(7)	Any other moneys collected pursuant to this chapter or
. 8		any rules adopted thereunder; and
9	(8)	Moneys derived from interest, dividends, or other
10		income from other sources.
11	(b)	The board may expend moneys from the dam and reservoir
12	safety spe	ecial fund for:
13	(1)	Conducting investigations, research, and the
14		collection of data, including technological advances
15		made in dam and reservoir safety practices elsewhere;
16	(2)	Conducting investigations, monitoring, and inspection
17		programs and activities, and enforcement;
18	(3)	Preparing and disseminating information to the public
19		concerning activities authorized under this chapter;
20	(4)	Training and providing educational activities for

department staff and dam and reservoir owners;

1	(5)	Employing any necessary remedial measures to protect
2		persons and property in accordance with this chapter;
3	(6)	The costs and expenses of the coordination,
4		assistance, control, regulation, abatement, and
5		inspection provided by this chapter; and
6	(7)	Other purposes for the administration of the dam and
7		reservoir safety program under this chapter or any
8		rule adopted thereunder, including but not limited to
9		funding permanent or temporary positions that may be
10		appointed without regard to chapter 76.
11	The board	shall provide coordination and assistance to the
12	proper sta	ate or county agency or agencies to control any dam,
13	reservoir	and appurtenances subject to section 179D-D until
14	they have	been rendered safe or the emergency has terminated.
15	(c)	Moneys on balance in the dam and reservoir safety

17	that fund	and shall not be transferred or lapsed to the credit

19	§179I	O-F Liens. (a) Costs of construction, enlargement,
20	repair, al	teration, or removal work done to render a dam,
21	reservoir,	or appurtenances safe shall constitute a statutory
22	lien agair	st all property of the owner. Notwithstanding any

- 1 other law to the contrary, the lien shall be considered prior
- 2 and superior to all other mortgages, liens, or encumbrances of
- 3 record even if those other mortgages, liens, or encumbrances
- 4 were filed before the lien pursuant to this subsection becomes
- 5 due.
- 6 (b) Liens pursuant to subsection (a) may be perfected and
- 7 foreclosed in advance of construction, enlargement, repair,
- 8 alteration, or removal or after completion of the construction,
- 9 enlargement, repair, alteration, or removal. If perfected in
- 10 advance, the lien shall be perfected by the filing of an
- 11 affidavit of the board setting forth the estimate of the costs
- 12 of construction, enlargement, repair, alteration, or removal
- 13 within the county in which the dam or reservoir is located in
- 14 the same manner as prescribed for mechanic's liens. When the
- 15 affidavit is filed, the amount set forth in the affidavit shall
- 16 be a lien in that amount against all property of the owner. If
- 17 the actual cost of construction, enlargement, repair,
- 18 alteration, or removal exceeds the estimated cost, the board may
- 19 amend the affidavit setting forth the additional estimated cost.
- 20 If the estimated cost exceeds the actual costs of construction,
- 21 enlargement, repair, alteration, or removal at completion, the
- 22 board shall file an amended affidavit at completion. If a lien

- 1 is perfected in advance and the construction, enlargement,
- 2 repair, alteration, or removal is not commenced within two years
- 3 from the date of perfection, the lien shall be void. The board
- 4 shall file a satisfaction of lien upon payment of the costs of
- 5 construction, enlargement, repair, alteration, or removal by the
- 6 owner.
- 7 §179D-G Dams and reservoirs completed prior to effective
- 8 date of this Act. (a) Every owner of a dam or reservoir that
- 9 falls within the definition of a dam or reservoir in this
- 10 chapter and was completed prior to the effective date of this
- 11 Act shall file with the board a separate application for a
- 12 certificate of approval to impound and any other supporting
- 13 information as required by the board for each dam or reservoir.
- 14 Each application shall also be accompanied by application fees
- 15 as required by the board. During the application process for a
- 16 certificate of approval to impound, the owner or operator of a
- 17 dam or reservoir may continue to impound water, unless the board
- 18 determines that the dam or reservoir may pose a danger to the
- 19 health and safety of persons or property.
- 20 (b) The board shall give notice to file an application for
- 21 certificate of approval to impound to owners of dams or

- 1 reservoirs who have failed to file such applications as required
- 2 by this chapter.
- 3 (c) The notice provided for in this section shall be
- 4 delivered by certified mail to the owner at the owner's last
- 5 address of record in the office of the county tax assessor in
- 6 which the dam or reservoir is located. The mailing shall
- 7 constitute service.
- 8 (d) The board shall make inspections of any dams and
- 9 reservoirs, unless the data, records, and inspection reports on
- 10 file with it are found adequate to enable a determination of
- 11 whether or not the certificate of approval to impound should be
- 12 issued.
- (e) The board shall require owners of the dams and
- 14 reservoirs to perform at their expense any work or tests as may
- 15 reasonably be required to disclose information sufficient to
- 16 enable the board to determine whether to issue certificates of
- 17 approval to impound, or to issue orders directing further work
- 18 at the owner's expense necessary to safeguard life and property.
- 19 For this purpose, the board may require an owner or operator to
- 20 lower the water level of, or to drain, the dam or reservoir.
- 21 (f) If, upon inspection or upon completion to the
- 22 satisfaction of the board of all work that may be ordered, the

- 1 board finds that the dam and reservoir are safe to impound
- 2 water, a certificate of approval to impound shall be issued.
- 3 The board may find that the dam or reservoir will not safely
- 4 impound water and may refuse to issue a certificate of approval
- 5 to impound. Upon finding that the dam or reservoir is unsafe to
- 6 impound water, the board shall issue a written notice to the
- 7 owner. After receipt of the notice, the owner shall no longer
- 8 cause or allow the dam and reservoir to impound water.
- 9 §179D-H Dams and reservoirs under construction,
- 10 enlargement, repair, alteration, or removal before effective
- 11 date of this Act. (a) Any dam or reservoir that falls within
- 12 the definitions of a dam or reservoir in this chapter and which
- 13 the board finds was under construction, enlargement, repair,
- 14 alteration, or removal, and based on its findings not more than
- 15 ninety per cent constructed, enlarged, repaired, altered, or
- 16 removed on the effective date of this Act, except as provided in
- 17 subsection (b), shall be subject to the same provisions in this
- 18 section as a dam or reservoir commenced after that date. Every
- 19 owner of a dam or reservoir subject to this section shall file
- 20 an application with the board for the board's written
- 21 application approval of the plans and specifications for the dam
- 22 or reservoir.

1	(b) Construction, enlargement, repair, alteration, or
2	removal work on the dam or reservoir may proceed; provided an
3	application for approval of the plans and specifications is
4	filed; until:
5	(1) An application approval is received by the owner
6	approving the dam or reservoir; or
7	(2) An order is received by the owner specifying how the
8	construction, enlargement, repair, alteration, or
9	removal must be performed to render the dam or
10	reservoir safe.
11	After receipt of an application approval or order specifying ho
12	construction, enlargement, repair, alteration, or removal of th
13	dam or reservoir must be performed, work thereafter must be in
14	accordance with the application approval or order.
15	§179D-I Annual report. The department shall submit an
16	annual report to the governor and the legislature by January 5
17	of each year concerning the activities of the department
18	relating to this chapter for the preceding fiscal year. The
19	report shall include but not be limited to information on the
20	following:

- Facilitate access by any necessary state agencies or (4)13 authorized representative, to the dam, reservoir, or 14 15 appurtenances. Access by a four-wheeled-drive vehicle to the dam or reservoir site, and appurtenances if 16 required by the board, shall be maintained at all 17 times; provided that if vehicular access to the dam or 18 19 reservoir site cannot be maintained during periods of inclement weather, the dam or reservoir owner for high 20 and significant hazard potential dams or reservoirs 21

11	SECTION 3. Section 179D-1, Hawaii Revised Statutes, is
12	amended to read as follows:
13	"[4] \$179D-1[+] Short title. This chapter shall be known
14	and may be cited as the "Hawaii Dam and Reservoir Safety Act of
15	[ <del>1987".</del> ] <u>2007".</u> "
16	SECTION 4. Section 179D-2, Hawaii Revised Statutes, is
17	amended to read as follows:
18	"[4] §179D-2[4] Declaration of purpose. The purpose of
19	this chapter is to provide for the inspection and regulation of
20	construction, enlargement, repair, alteration, maintenance,
21	operation, and removal of [eertain] all dams [in order] or
22	reservoirs to protect the health, safety, and welfare of the

- 1 citizens of the [State] state by reducing the risk of failure of
- 2 [such] the dams[-] or reservoirs. The legislature finds and
- 3 declares that the inspection and regulation of [construction,
- 4 operation, and removal of certain] all dams or reservoirs are
- 5 properly a matter of regulation under the police powers of the
- 6 State[-], unless specifically exempted.
- 7 The board shall have jurisdiction of all dams and
- 8 reservoirs until the department has completed its statewide
- 9 inspections and has established and implemented rules and
- 10 criteria for a five year dams and reservoirs inspection and
- 11 classification processes and the board declares which dams or
- 12 reservoirs are to be removed from its jurisdiction."
- 13 SECTION 5. Section 179D-3, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- "[4] \$179D-3[+] Definitions. The following terms, whenever
- 16 used and referred to in this chapter, shall have the following
- 17 [respective] meanings, unless a different meaning clearly
- 18 appears in the context:
- "Application approval" means authorization in writing
- 20 issued by the board to an owner who has applied to the board for
- 21 permission to construct, enlarge, repair, alter, remove,
- 22 maintain, or operate a dam or reservoir and that specifies the




- 1 condition or limitations under which work is to be performed by
- 2 the owner or under which approval is granted.
- 3 "Appurtenant works" or "appurtenance" means any structure,
- 4 such as spillways[, either] in the dam or separate therefrom,
- 5 the reservoir and its rim, low level outlet works, and water
- 6 conduits, such as tunnels, pipelines, or penstocks, [either]
- 7 through the dam or its abutment.
- 8 "Board" means the board of land and natural resources.
- 9 "Certificate of approval to impound" means authorization in
- 10 writing issued by the board to an owner of an existing dam or
- 11 reservoir, or an owner who has completed construction,
- 12 enlargement, repair, or alteration of a dam or reservoir, that
- 13 specifies the conditions or limitations under which the dam or
- 14 reservoir is to be maintained and operated.
- "Dam" means any artificial barrier, including appurtenant
- 16 works [-which] that impounds or diverts water [-] and [which:]
- 17 that:
- 18 (1) Is twenty-five feet or more in height from the natural
- 19 bed of the stream or watercourse measured at the
- 20 downstream toe of the barrier, or from the lowest
- 21 elevation of the outside limit of the barrier if it is

1		not across a stream channel or watercourse to a
2		maximum water storage elevation; [or]
3	(2)	Has an impounding capacity at maximum water storage
4		elevation of fifty acre-feet or more. This chapter
5		[does] shall not apply to any artificial barrier
6		[which] that is less than six feet in height
7		regardless of storage capacity or [which] that has a
8		storage capacity at maximum water storage elevation
9		less than fifteen acre-feet regardless of height[-];
10		<u>or</u>
11	(3)	Meets additional criteria or is specifically exempt as
12		determined pursuant to rules adopted by the board.
13	"Dep	artment" means the department of land and natural
14	resources	
15	"Eme:	rgency" includes but is not limited to breaches and all
16	condition	s leading to or causing a breach, overtopping, or any
17	other con	dition in a dam or reservoir and its appurtenant works
18	that may l	be construed as unsafe or threatening to life and
19	property.	
20	"Enla	argement" means any change in or addition to an
21	existing o	dam or reservoir that raises or may raise the water

- 1 storage elevation of the water impounded by the dam or
- 2 reservoir.
- 3 "Hazard potential" means the possible adverse incremental
- 4 consequences that result from the release of water or stored
- 5 contents due to the failure of the dam or reservoir or the
- 6 misoperation of the dam, reservoir, or appurtenances. The
- 7 hazard potential classification of a dam or reservoir shall not
- 8 reflect in any way on the current condition of the dam or
- 9 reservoir and its appurtenant works, including the dam's or
- 10 reservoir's safety, structural integrity, or flood routing
- 11 capacity.
- "High hazard" means a dam's or reservoir's failure will
- 13 result in probable loss of human life.
- "Low hazard" means a dam's or reservoir's failure will
- 15 result in no probable loss of human life and low economic loss
- 16 or environmental loss, or both. Economic losses are principally
- 17 limited to the owner's property.
- 18 "Operator" means any person who controls, manages,
- 19 maintains, or supervises the condition and functions of a dam or
- 20 reservoir.
- "Owner" means any person who [owns, controls, operates,
- 22 maintains, manages, or proposes to construct a dam or



- reservoir.] has a right, title, or interest in or to the dam or 1
- 2 reservoir or to the property upon which the dam, reservoir, or
- 3 appurtenant works is located or proposed to be located.
- 4 "Person" means [any individual, partnership, corporation,
- 5 company, association, organization, the State and its
- 6 departments and agencies, and the political subdivisions of the
- 7 State.] any natural person, partnership, firm, association,
- 8 organization, corporation, county, county authority, trust,
- 9 receiver or trustee, limited liability company, limited
- 10 liability partnership, or company, or any state department,
- 11 agency, or political subdivision, or any other commercial or
- 12 legal entity. Whenever used in a section prescribing and
- imposing a penalty or sanction, the term "person" includes the 13
- 14 members of an association or organization, and the officers of a
- corporation, company, county, or county authority. 15
- "Physical clear access" means a roadway or path that allows 16
- 17 timely access for inspection to a dam, reservoir, and its
- 18 appurtenant works. If by a roadway, the roadway shall be
- maintained in an accessible condition by a four-wheel drive 19
- 20 vehicle even during inclement weather conditions.
- "Probable" means more likely than not to occur; reasonably 21
- expected; realistic. 22



- 1 "Removal" means complete or partial elimination of the dam
- 2 or reservoir embankment or structure to restore the approximate
- 3 original topographic contours of the valley.
- 4 "Reservoir" means any basin [which] that contains or will
- 5 contain water impounded by a dam[-], including appurtenant
- 6 works.
- 7 "Significant hazard" means a dam's or reservoir's failure
- 8 will result in no probable loss of human life but can cause
- 9 major economic loss, environmental damage, disruption of
- 10 lifeline facilities, or impact other concerns. Significant
- 11 hazard potential classification dams or reservoirs are often
- 12 located in predominantly rural or agricultural areas but could
- 13 be located in areas with population and significant
- 14 infrastructure."
- 15 SECTION 6. Section 179D-4, Hawaii Revised Statutes, is
- 16 amended to read as follows:
- 18 contained in this chapter shall be construed to constitute a
- 19 waiver of any immunity of the State and no action or failure to
- 20 act under this chapter shall be construed to create any
- 21 liability in the State, board, department, or its officers or

- 1 employees, for the recovery of damages caused by [such] the
- 2 action or failure to act.
- 3 (b) Nothing in this chapter and no order, action, or
- 4 advice of the State, board, department, or any representative
- 5 thereof, shall be construed to relieve an owner or operator of a
- 6 dam or reservoir of the legal duties, obligations, or
- 7 liabilities incident to the ownership or operation of a dam or
- 8 reservoir; provided that an owner or operator of a dam or
- 9 reservoir shall not be liable for damages as a result of only
- 10 natural causes such as earthquakes  $[\tau]$  of an average recurrence
- 11 interval of one thousand years, hurricanes, or extraordinary
- 12 rains of an average recurrence interval in excess of two hundred
- 13 fifty years.
- 14 (c) The State assumes no ownership obligations,
- 15 responsibilities, or liability for any action pursuant to
- 16 section 179D-D."
- 17 SECTION 7. Section 179D-6, Hawaii Revised Statutes, is
- 18 amended to read as follows:


