Dear Madam President and Members of the Senate:

Re: Senate Bill No. 1614 SD1 HD1 CD1

On July 10, 2007, Senate Bill No. 1614, entitled "A Bill for an Act Relating to Education" became law without my signature, pursuant to Section 16 of Article III of the Constitution of the State of Hawaii.

This bill appropriates \$1 million over the biennium period to the Department of Education to implement a human resources management model in the Waianae area complex.

It is important for schools to be able to recruit, train, and retain good teachers. However, it should be pointed out that the Department already has over \$12 million specifically allocated for teacher training and teacher retention. Over \$2.2 million is provided for teacher recruitment and \$5 million has been set aside for professional development, not counting funds imbedded in other administrative support programs.

The Waianae area should be commended for receiving a \$1 million grant from the U. S. Department of Education to implement teacher recruitment and retention systems targeted for their high school. This three-year grant still has two more years before the project is complete.

Thus, the funding in this bill duplicates resources already within the Department of Education budget and is premature. We would encourage the Waianae area complex to continue the work it has begun under the U. S. Department of Education grant and to provide a comprehensive post-project analysis that can be used by schools in that area, as well as elsewhere throughout the public education system to help identify, place, and retain high quality teachers.

For this reason, I allowed Senate Bill No. 1614 to become law as Act 268, effective July 10, 2007, without my signature.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the recruitment and 2 retention of high-quality teachers are fundamental components of 3 a high-guality education system for Hawaii's children. Act 51, Session Laws of Hawaii 2004, notes that other than home and 4 societal factors, teacher quality is the single most influential 5 factor in student achievement. While the State hires over one 6 7 thousand three hundred new teachers each year, the University of Hawaii graduates only four hundred to four hundred fifty 8 9 teachers per year.

10 At Waianae high school, there are approximately one hundred 11 fifty teachers serving the needs of two thousand students, the 12 majority of whom are native Hawaiians and are living at or below the poverty level. Currently, only fifty-six per cent of 13 teachers at Waianae high school are fully licensed. 14 15 Additionally, Waianae high school and all but one of its 16 elementary and intermediate feeder schools are being 17 restructured due to failures in student learning.

The urgency of improving teacher quality at Waianae high 1 school has led to the awarding of a multi-year federal native 2 Hawaiian education program grant that provides resources to 3 design a model for Waianae high school. Waianae high school and 4 5 the Waianae High School Alumni Association are the program grant recipients. The new human resource management model will allow 6 the school to achieve a significantly greater level of fully 7 8 licensed teachers.

9 The purpose of this Act is to appropriate funds to a pilot 10 project that implements a new human resource management model 11 for Waianae high school and its elementary and intermediate 12 feeder schools. The funds would complement the federal grant 13 funds and allow for the extension of the recruitment, induction, 14 and mentoring model to elementary, middle, and high school 15 students.


16 SECTION 2. The Waianae complex schools shall submit to the 17 legislature, no later than twenty days prior to the convening of 18 the regular session of 2008, a written report that includes:

19 (1) Baseline data on teacher qualifications at each school
20 in the Waianae complex;

14	2008-2009,	, for the implementation of a new human resource
15	management	model for the Waianae complex schools, including
16	Waianae hi	igh school and its elementary and intermediate feeder

18 The sums appropriated shall be expended by the department 19 of education for the purposes of this Act.

20 SECTION 4. This Act shall take effect on July 1, 2007.
