A BILL FOR AN ACT

RELATING TO PETROLEUM INDUSTRY MONITORING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 486B, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "<u>\$486B-A</u> Monitoring of petroleum industry information.
- 5 The public utilities commission shall refer to the attorney
- 6 general any matter that is a violation of this chapter that is
- 7 discovered in the performance of its duties pursuant to chapter
- **8** 486H or 486J."
- 9 SECTION 2. Chapter 486J, Hawaii Revised Statutes, is
- 10 amended by adding a new section to be appropriately designated
- 11 and to read as follows:
- 12 "§486J-A Use and analysis of information by the department
- of business, economic development, and tourism. The department,
- 14 with its own staff and other support staff with relevant
- 15 expertise and experience, shall use the information obtained
- 16 under this chapter to effectuate the purposes of chapters 125C,
- 17 196, and other relevant laws."



- SECTION 9. Section 486J-8, Hawaii Revised Statutes, is amended by amending subsection (b) to read as follows:
- "(b) [Notwithstanding any law to the contrary, including
 any other section of this chapter, no later than fourteen days
 after the reporting date established by the commission under
 section 486J-3, the] The commission shall disclose to the
 public, using the best readily available technology, the
 information contained in the statements [, but not the statements

- 8 SECTION 13. In codifying the new sections added to the

- 10 shall substitute appropriate section numbers for the letters
- 11 used in designating the new sections in this Act.
- 12 SECTION 14. Statutory material to be repealed is bracketed
- 13 and stricken. New statutory material is underscored.
- 14 SECTION 15. This Act shall take effect on July 1, 2007.
