RELATING TO DISASTER PREPAREDNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 10 | "Disaster" means any natural or man-made catastrophe, the |
| 11 | occurrence of which is unanticipated or difficult to predict, |
| 12 | that results in significant property damage, hardship, |
| 13 | suffering, or loss of life within the state. |
| 14 | "Natural hazard" means hurricane, storm, flood, tsunami, |
| 15 | tidal wave, wind-driven water, earthquake, volcanic activity, |
| 16 | lava flow, rockslide, earthslide, fire, or other natural |
| 17 | disaster. |

1 S -2 Office of the director of disaster preparedness 2 established. There is established in the department of 3 accounting and general services the office of the director of 4 disaster preparedness. The director shall be nominated and, by 5 and with the advice and consent of the senate, appointed by the 6 governor. The director shall serve for a period of six years 7 and thereafter until a successor is appointed. The salary of 8 the director shall be set at a rate no greater than \$ а 9 year and shall not be diminished during the director's term of 10 office unless by general law applying to all salaried officers 11 of the State. If the director dies, resigns, becomes ineligible 12 to serve, or is removed or suspended from office, the first 13 assistant to the director shall become the acting director until 14 a new director is appointed for a full term.

15 § -3 Duties of the director. (a) The director shall
16 develop a comprehensive disaster preparedness plan for the State
17 of Hawaii. The disaster preparedness plan shall include but not
18 be limited to:

Priorities for natural hazard mitigation;

1 (4) Policies, requirements, and incentives to mitigate the 2 problems caused by natural hazards, such as county 3 building codes, land use policies, and retrofitting 4 incentives such as tax credits; and 5 (5) Plans for best responses to natural and other 6 disasters to minimize costs and protect the interests 7 of Hawaii's residents and their possessions and pets, 8 and visitors to the state, including plans ensuring 9 the reliability of communication networks and power 10 supplies for major state airports, health care 11 facilities, and other essential services. 12 (b) The director shall report annually to the governor and 13

13 the legislature no later than twenty days before the convening 14 of each regular session of the legislature on the status of the 15 disaster preparedness plan, and shall include any proposed 16 legislation.
