A BILL FOR AN ACT

RELATING TO PRESCRIPTION DRUGS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 241, Session Laws of Hawaii 2005, added a
- 2 new part to chapter 346, Hawaii Revised Statutes, entitled
- 3 "Medicaid Preauthorization Exemption", which consists of two
- 4 sections codified as sections 346-351 and 346-352, Hawaii
- 5 Revised Statutes exempts physicians prescribing
- 6 immunosuppressant medication under medicaid from
- 7 preauthorization procedures. However, section 346-352 excludes
- 8 QUEST medical plans from this exemption and thereby restricts
- 9 access of QUEST medicaid recipients to immunosuppressant
- 10 medication.
- 11 The purpose of this Act is to delete the QUEST medical
- 12 plans exclusion in section 346-352. Deletion of this exclusion
- 13 will provide equal access to medications for medicaid clients
- 14 who suffer from human immunodeficiency virus, acquired immune
- 15 deficiency syndrome, or hepatitis C, or who need
- 16 immunosuppressives as a result of organ transplants, regardless
- 17 of whether they are in the medicaid fee-for-service or the
- 18 medicaid QUEST program.

- 1 SECTION 2. Section 346-352, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "[+]§346-352[+] Preauthorization exemption for certain
- 4 physicians. Any physician licensed in this State who treats a
- 5 medicaid recipient patient suffering from the human
- 6 immunodeficiency virus, acquired immune deficiency syndrome, or
- 7 hepatitis C, or who is a patient in need of transplant
- 8 immunosuppressives, may prescribe any medications approved by
- 9 the United States Food and Drug Administration and that are
- 10 eligible [for] pursuant to the Omnibus Budget Reconciliation
- 11 Rebates Act (OBRA), that are necessary to treat the condition,
- 12 without having to comply with the requirements of any
- 13 preauthorization procedure established by any other provision of
- 14 this chapter. [This section shall not apply to QUEST medical
- 15 plans.]"
- 16 SECTION 3. The department of human services shall prepare
- 17 an economic impact assessment report including findings,
- 18 recommendations, and any proposed legislation, to the
- 19 legislature no later than twenty days prior to the convening of
- 20 the 2010, 2011, and 2012 regular sessions. The economic impact
- 21 assessment report shall include information obtained from
- 22 insurance providers who provide medicaid and QUEST coverage on

- 1 the additional costs incurred as a result of providing access to
- 2 immunosuppressant medication to QUEST patients suffering from
- 3 the conditions as described in section 346-352, Hawaii Revised
- 4 Statutes, under this Act.
- 5 SECTION 4. Statutory material to be repealed is bracketed
- 6 and stricken. New statutory material is underscored.
- 7 SECTION 5. This Act shall take effect upon its approval,
- 8 and shall be repealed on July 1, 2013.

Report Title:

Medicaid; Immunosuppressant Medication

Description:

Provides equal access to immunosuppressant medication for Medicaid patients with HIV, AIDS, or Hepatitis C, or who require immunosuppressives due to organ transplants, regardless of whether they are in the Medicaid fee for service or QUEST programs. Requires economic impact assessment. Sunsets July 1, 2013. (HB1044 HD1)
