A BILL FOR AN ACT

RELATING TO MARRIAGE AND FAMILY THERAPISTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 431M-1, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "\$431M-1 Definitions. Whenever used in this chapter,
- 4 unless the context otherwise requires:
- 5 "Advanced practice registered nurse" means a person
- 6 recognized as such pursuant to chapter 457.
- 7 "Alcohol dependence" means any use of alcohol which
- 8 produces a pattern of pathological use causing impairment in
- 9 social or occupational functioning or produces physiological
- 10 dependency evidenced by physical tolerance or withdrawal.
- 11 "Alcohol or drug dependence outpatient services" means
- 12 alcohol or drug dependence nonresidential treatment provided on
- 13 an ambulatory basis to patients with alcohol or drug dependence
- 14 problems that includes interventions prescribed and performed by
- 15 qualified physicians, psychologists, licensed clinical social
- 16 workers, marriage and family therapists, or advanced practice
- 17 registered nurses. This definition shall not imply a broadening

- 1 of the scope of or granting of prescriptive authority
- 2 privileges, except as otherwise allowed pursuant to chapter 457.
- 3 "Certified substance abuse counselor" means a person who is
- 4 certified pursuant to section 321-193.
- 5 "Day treatment services" means treatment services provided
- 6 by a hospital, mental health outpatient facility, or nonhospital
- 7 facility to patients who, because of their conditions, require
- 8 more than periodic hourly service. Day treatment services shall
- 9 be prescribed by a physician, psychologist, licensed clinical
- 10 social worker, <u>marriage</u> and family therapist, or advanced
- 11 practice registered nurse, and carried out under the supervision
- 12 of a physician, psychologist, licensed clinical social worker,
- 13 marriage and family therapist, or advanced practice registered
- 14 nurse. Day treatment services require less than twenty-four
- 15 hours of care and a minimum of three hours in any one day.
- "Detoxification services" means the process whereby a
- 17 person intoxicated by alcohol, drugs, or both, or a person who
- 18 is dependent upon alcohol, drugs, or both, is assisted through
- 19 the period of time necessary to eliminate, by metabolic or other
- 20 means, the intoxicating alcohol or drug dependency factors, as
- 21 determined by a physician or advanced practice registered nurse,
- 22 while keeping the physiological risk to the person at a minimum.

- 1 "Drug dependence" means any pattern of pathological use of drugs causing impairment in social or occupational functioning 2 3 and producing psychological or physiological dependency or both, 4 evidenced by physical tolerance or withdrawal. "Hospital" means a facility licensed as a hospital by the 5 6 department of health and accredited by the Joint Commission on 7 Accreditation of Health Care Organizations. 8 "In-hospital services" means the provision of medical, 9 nursing, or therapeutic services twenty-four hours a day in a 10 hospital. "Licensed clinical social worker" means a person who is a 11 12 licensed clinical social worker pursuant to chapter 467E. "Marriage and family therapist" means a person licensed in 13
- marriage and family therapy practice pursuant to chapter 451J.

 "Mental health outpatient facility" means a mental health

 establishment, clinic, institution, center, or community mental

 health center, that provides for the diagnosis, treatment, care,

 or rehabilitation of mentally ill persons, that has been

 accredited by the Joint Commission on Accreditation of Health
- 20 Care Organizations or the Commission on Accreditation of
- 21 Rehabilitation Facilities or certified by the department of
- 22 health.

"Mental health outpatient services" means mental health 1 2 nonresidential treatment provided on an ambulatory basis to 3 patients with mental illness that includes interventions prescribed and performed by a physician, psychologist, licensed 4 5 clinical social worker, marriage and family therapist, or 6 advanced practice registered nurse. 7 "Mental illness" means a syndrome of clinically significant psychological, biological, or behavioral abnormalities that 8 9 results in personal distress or suffering, impairment of 10 capacity for functioning, or both. For the purposes of this chapter, the terms "mental disorder" and "mental illness" shall 11 be used interchangeably and shall include the definitions 12 13 identified in the most recent publications of the Diagnostic and 14 Statistical Manual of the American Psychiatric Association or 15 International Classification of Disease. Epilepsy, senility, 16 mental retardation, or other developmental disabilities and 17 addiction to or abuse of intoxicating substances do not in and of themselves constitute a mental disorder. 18 19 "Nonhospital facility" means a facility for the care or 20 treatment of alcohol dependent, drug dependent, or mentally ill 21 persons, which has been accredited by the Joint Commission on 22 Accreditation of Health Care Organizations or the Commission on

1 Accreditation of Rehabilitation Facilities or certified by the department of health and, if residential, has been licensed as a 2 3 special treatment facility by the department of health. "Nonhospital residential services" means the provision of 4 5 medical, psychological, nursing, counseling, or therapeutic 6 services to patients suffering from alcohol dependence, drug 7 dependence, or mental illness by a nonhospital residential 8 facility, according to individualized treatment plans. "Partial hospitalization services" means treatment 9 10 services, including in-hospital treatment services or benefits, 11 provided by a hospital or mental health outpatient facility to patients who, because of their conditions, require more than 12 13 periodic hourly service. Partial hospitalization services shall 14 be prescribed by a physician or psychologist, and may be 15 prescribed by a marriage and family therapist or licensed 16 clinical social worker in consultation with a physician or 17 psychologist or an advanced practice registered nurse in 18 consultation with a physician or psychologist. Partial

hospitalization services require less than twenty-four hours of

care and a minimum of three hours in any one day.

1 "Physician" means a person licensed in the practice of 2 medicine or osteopathy pursuant to chapter 453 or 460, 3 respectively. "Psychologist" means a person licensed in the practice of 4 5 psychology pursuant to chapter 465. 6 "Qualified" means: Having skill in the diagnosis or treatment of 7 (1)substance use disorders, based on a practitioner's 8 9 credentials, including but not limited to professional 10 education, clinical training, licensure, board or other certification, clinical experience, letters of 11 reference, other professional qualifications, and 12 disciplinary action; or 13 14 (2) Being a licensed physician, psychologist, licensed clinical social worker, marriage and family therapist, 15 or advanced practice registered nurse, and certified 16 17 pursuant to chapter 321. 18 "Serious mental illness" means a mental disorder consisting 19 of at least one of the following: schizophrenia, schizoaffective disorder, bipolar types I and II, obsessive compulsive 20 disorder, dissociative disorder, delusional disorder, and major 21

depression, as defined in the most recent version of the

- 2 Association and which is of sufficient severity to result in
- 3 substantial interference with the activities of daily living.
- 4 "Substance abuse services" means the provision of medical,
- 5 psychological, nursing, counseling, or therapeutic services in
- 6 response to a treatment plan for alcohol or drug dependence or
- 7 both which shall include, when appropriate, a combination of
- 8 aftercare and individual, group, and family counseling services
- 9 provided by qualified staff.
- 10 "Treatment episode" means one admission to an accredited
- 11 hospital or nonhospital facility, or office of a qualified
- 12 physician, psychologist, licensed clinical social worker,
- 13 marriage and family therapist, or advanced practice registered
- 14 nurse for treatment of alcohol or drug dependence, or both, as
- 15 stipulated in a prescribed treatment plan and that would
- 16 generally produce remission in those who complete the treatment.
- 17 The prescribed treatment plan may include the provision of
- 18 substance abuse services in more than one location and may
- 19 include in-hospital, nonhospital residential, day treatment, or
- 20 alcohol or drug dependence outpatient services, or any
- 21 combination thereof. An admission for only detoxification
- 22 services shall not constitute a treatment episode."



- 1 SECTION 2. Section 431M-3, Hawaii Revised Statutes, is
- 2 amended by amending subsection (a) to read as follows:
- 3 "(a) Covered benefits for alcohol dependence, drug
- 4 dependence, or mental illness insurance policies, hospital or
- 5 medical service plan contracts, and health maintenance
- 6 organization health plan contracts shall be limited to those
- 7 services certified by the insurance or health care plan
- 8 carrier's physician, psychologist, licensed clinical social
- 9 worker, marriage and family therapist, or advanced practice
- 10 registered nurse as medically or psychologically necessary at
- 11 the least restrictive appropriate level of care."
- 12 SECTION 3. Section 431M-4, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- 14 "\$431M-4 Mental illness, alcohol and drug dependence
- 15 benefits. (a) The covered benefit under this chapter shall not
- 16 be less than thirty days of in-hospital services per year. Each
- 17 day of in-hospital services may be exchanged for two days of
- 18 nonhospital residential services, two days of partial
- 19 hospitalization services, or two days of day treatment services.
- 20 Visits to a physician, psychologist, licensed clinical social
- 21 worker, marriage and family therapist, or advanced practice
- 22 registered nurse shall not be less than thirty visits per year



- 1 to hospital or nonhospital facilities or to mental health
- 2 outpatient facilities for day treatment or partial
- 3 hospitalization services. Each day of in-hospital services may
- 4 also be exchanged for two outpatient visits under this chapter;
- 5 provided that the patient's condition is such that the
- 6 outpatient services would reasonably preclude hospitalization.
- 7 The total covered benefit for outpatient services in subsections
- 8 (b) and (c) shall not be less than twenty-four visits per year;
- 9 provided that coverage of twelve of the twenty-four outpatient
- 10 visits shall apply only to the services under subsection (c).
- 11 The other covered benefits under this chapter shall apply to any
- 12 of the services in subsection (b) or (c). In the case of
- 13 alcohol and drug dependence benefits, the insurance policy may
- 14 limit the number of treatment episodes but may not limit the
- 15 number to less than two treatment episodes per lifetime.
- 16 Nothing in this section shall be construed to limit serious
- 17 mental illness benefits.
- 18 (b) Alcohol and drug dependence benefits shall be as
- 19 follows:
- 20 (1) Detoxification services as a covered benefit under
- 21 this chapter shall be provided either in a hospital or
- in a nonhospital facility that has a written

1		affiliation agreement with a hospital for emergency,
2		medical, and mental health support services. The
3		following services shall be covered under
4		detoxification services:
5		(A) Room and board;
6		(B) Diagnostic x-rays;
7		(C) Laboratory testing; and
8		(D) Drugs, equipment use, special therapies, and
9		supplies.
10		Detoxification services shall be included as part of
11		the covered in-hospital services, but shall not be
12		included in the treatment episode limitation, as
13		specified in subsection (a);
14	(2)	Alcohol or drug dependence treatment through
15		in-hospital, nonhospital residential, or day treatment
16		substance abuse services as a covered benefit under
17		this chapter shall be provided in a hospital or
18		nonhospital facility. Before a person qualifies to
19		receive benefits under this subsection, a qualified
20		physician, psychologist, licensed clinical social
21		worker, marriage and family therapist, or advanced
22		practice registered nurse shall determine that the

person suffers from alcohol or drug dependence, or
both; provided that the substance abuse services
covered under this paragraph shall include those
services that are required for licensure and
accreditation and shall be included as part of the
covered in-hospital services as specified in
subsection (a). Excluded from alcohol or drug
dependence treatment under this subsection are
detoxification services and educational programs to
which drinking or drugged drivers are referred by the
judicial system and services performed by mutual self-
help groups;

(3) Alcohol or drug dependence outpatient services as a covered benefit under this chapter shall be provided under an individualized treatment plan approved by a qualified physician, psychologist, licensed clinical social worker, marriage and family therapist, or advanced practice registered nurse and shall be services reasonably expected to produce remission of the patient's condition. An individualized treatment plan approved by a marriage and family therapist, licensed clinical social worker, or an advanced

1		practice registered nurse for a patient already under
2		the care or treatment of a physician or psychologist
3		shall be done in consultation with the physician or
4		psychologist. Services covered under this paragraph
5		shall be included as part of the covered outpatient
6		services as specified in subsection (a); and
7	(4)	Substance abuse assessments for alcohol or drug
8		dependence as a covered benefit under this section for
9		a child facing disciplinary action under section
10		302A-1134.6 shall be provided by a qualified
11		physician, psychologist, licensed clinical social
12		worker, marriage and family therapist, advanced
13		practice registered nurse, or certified substance
14		abuse counselor. The certified substance abuse
15		counselor shall be employed by a hospital or
16		nonhospital facility providing substance abuse
17		services. The substance abuse assessment shall
18		evaluate the suitability for substance abuse treatment
19		and placement in an appropriate treatment setting.
20	(c)	Mental illness benefits.
21	(1)	Covered benefits for mental health services set forth

2		mental health services shall be provided under an
3		individualized treatment plan approved by a physician,
4		psychologist, licensed clinical social worker,
5		marriage and family therapist, or advanced practice
6		registered nurse and must be reasonably expected to
7		improve the patient's condition. An individualized
8		treatment plan approved by a marriage and family
9		therapist, licensed clinical social worker or an
10		advanced practice registered nurse for a patient
11		already under the care or treatment of a physician or
12		psychologist shall be done in consultation with the
13		physician or psychologist;
14	(2)	In-hospital and nonhospital residential mental health
15		services as a covered benefit under this chapter shall
16		be provided in a hospital or a nonhospital residential
17		facility. The services to be covered shall include
18		those services required for licensure and
19		accreditation, and shall be included as part of the
20		covered in-hospital services as specified in
21		subsection (a);



1	(3)	Mental health partial hospitalization as a covered
2		benefit under this chapter shall be provided by a
3		hospital or a mental health outpatient facility. The
4		services to be covered under this paragraph shall
5		include those services required for licensure and
6		accreditation and shall be included as part of the
7		covered in-hospital services as specified in
8		subsection (a); and
9	(4)	Mental health outpatient services shall be a covered
10		benefit under this chapter and shall be included as
11		part of the covered outpatient services as specified
12		in subsection (a)."
