H.B. NO. (05)

A BILL FOR AN ACT

RELATING TO ELECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that in the 2006 SECTION 1. 2 elections, absentee voters were significantly confused due to 3 ballot design and unclear instructions. Voter experience in 4 other states indicate that clarity in ballot design is important 5 to avoid confusion and ambiguity. The legislature finds that 6 the voting process should be clear to ensure that voters' 7 preferences are accurately expressed, and to provide a 8 satisfying experience for voters in fulfilling their civic duty. 9 Although the office of elections has occasionally convened 10 meetings of an ad hoc elections advisory council to provide 11 input informally, the elections advisory council is not a 12 statutory body.

13 The purpose of this Act is to establish:

14 (1) The elections advisory council in statute; and

(2) Provide a ballot design review process.
