# A BILL FOR AN ACT

RELATING TO MILITARY AFFAIRS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that burials for
2	qualified veterans and their dependents in veterans cemeteries
3	on Hawaii, Kauai, Maui, Molokai, Lanai, and at the Hawaii state
4	veterans cemetery on Oahu is an honor reserved for those who
5	served their country in either peacetime or wartime.
6	Establishment of these veterans cemeteries reflects the
7	commitment of the people of Hawaii to those who served in the
8	armed forces of the United States.
9	The legislature further finds that Hawaii's veterans
10	cemeteries suffer from inadequate care and maintenance due to
11	the lack of sufficient funding necessary to maintain these
12	facilities at the level they deserve. For example, the soil
13	used at veterans cemeteries is not suitable for re-use as back-
14	fill in graves due to its composition and moisture content.
15	This substandard soil fails to provide the necessary support for
16	graves and headstones, causing them to sink in unsightly holes
17	that mar the landscape and desecrate the sanctity of the

cemetery. To remedy the problem, appropriate soil and casket
 liners are necessary.

3 The purpose of this Act is to provide adequate funds for
4 the care and maintenance of veterans cemeteries statewide,
5 including but not limited to the purchase of casket liners to
6 help remedy the soil problems at the cemeteries.

7 SECTION 2. There is appropriated out of the general 8 revenues of the State of Hawaii the sum of \$ or so much 9 thereof as may be necessary for fiscal year 2007-2008 and the 10 same sum or so much thereof as may be necessary for fiscal year 11 2008-2009 for the purchase of casket liners to help remedy the 12 soil problems at the cemeteries.

13 The sums appropriated shall be expended by the department14 of defense for the purposes of this Act.

15 SECTION 3. There is appropriated out of the general 16 revenues of the State of Hawaii the sum of \$ or so much 17 thereof as may be necessary for fiscal year 2007-2008 and the 18 same sum or so much thereof as may be necessary for fiscal year 19 2008-2009 for the maintenance of state veterans cemeteries 20 statewide.

The sums appropriated shall be expended by the department
 of defense for the purposes of this Act.

3 SECTION 4. This Act shall take effect on July 1, 2015.
