## A BILL FOR AN ACT

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 201H, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	" <u>§201H-</u> Affordable housing inventory protection board.
5	(a) There is established the affordable housing inventory
6	protection board. The board shall be attached to the Hawaii
7	housing finance and development corporation for administrative
8	purposes only.
9	(b) The board shall:
10	(1) Annually calculate, maintain, and disburse to the
11	legislature accurate recorded estimates of the
12	existing and potential supply of all categories of
13	affordable housing in the State;
14	(2) Annually calculate, maintain, and disburse to the
15	legislature accurate recorded estimates of the
16	existing and potential demand for all categories of
17	affordable housing in the State; and

1	(3)	Recommend to relevant governmental agencies
2		suggestions to encourage the accumulation and

6	(c)	The board shall be composed of nine members who shall
7	be appoin	ted by the governor pursuant to section 26-34. Three
8	of the me	mbers shall be selected by the governor from a list of
9	nominees	submitted by the president of the senate and three

11	submitted	by the speaker of the house of representatives. All
