# A BILL FOR AN ACT

RELATING TO ELECTION DAY REGISTRATION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that a voter registration		
2	deadline thirty days prior to an election does not encourage		
3	participation in the electoral process and that many citizens do		
4	not become passionate about the electoral process until after		
5	the registration deadline. The legislature further finds that		
6	election day registration will allow more citizens to		
7	participate in the electoral process.		
8	The purpose of this Act is to provide for voter		
9	registration on election day; provided the voter can prove		
10	residency in the district.		
11	SECTION 2. Chapter 11, Hawaii Revised Statutes, is amended		
12	by adding a new section to be appropriately designated and to		
13	read as follows:		
14	" <b>§11- Election day registration</b> . (a) Persons seeking		
15	to vote on primary, special primary, special, general, or		
16	special general election day may register on that election day		
17	by appearing during the hours of voting in person at the polling		
18	place for the precinct in which the person maintains residence,
