A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR DEVELOPMENT OF A NON-EMERGENCY REPORTING SYSTEM, KNOWN AS 3-1-1.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) In 1997, the Federal Communications
- 2 Commission designated "3-1-1" as a non-emergency one-stop phone
- 3 number for public services. As a result of that designation,
- 4 the city and county of Honolulu proposes to develop a 3-1-1
- 5 system to better serve the residents of the State. The city and
- 6 county of Honolulu, through the mayor's office and the customer
- 7 services department, is currently defining requirements for a 3-
- 8 1-1 system, working together with first responders and neighbor
- 9 island counties. The city and county of Honolulu will create a
- 10 model of 3-1-1 that can be designed to allow any county to
- 11 participate and also provide support for state functions.
- 12 Initially, this system can be used to relieve the 9-1-1
- 13 system of non-emergency phone calls, that number over one
- 14 million calls annually. Subsequently, the services could expand
- 15 to include all of the services offered by each county,
- 16 including, but not limited to, the following:
- 17 (1) Non-emergency police services;

(6) Other topics and issues. 2 The legislature further finds that a 3-1-1 system is 3 necessary to protect the public health, safety and welfare, 4 while providing better access to public services. 5 The purpose of this Act is to provide a grant-in-aid 6 appropriation to the city and county of Honolulu to leverage 7 Honolulu's study, that will define a 3-1-1 system and develop 8 the infrastructure to implement the system state-wide. The 3-1-9 1 system would include a web site, personnel to handle telephone 10 requests, a call and records management system, and a database of information to support the 3-1-1 system. The 3-1-1 system 11 12 will also include an educational component to enable users to 13 effectively access, use, and obtain general information 14 regarding the system. 15 SECTION 2. There is appropriated out of the general 16 revenues of the State of Hawaii the sum of \$2,125,000, or so much thereof as may be necessary for the fiscal year 2007-2008, 17 for a grant-in-aid to the city and county of Honolulu to build 18 19 the infrastructure for a 3-1-1 non-emergency reporting system 20 for all counties that decide to participate. The system shall 21 include:
