RELATING TO OFFENSE AGAINST THE PUBLIC ADMINISTRATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 710, part II, Hawaii Revised Statutes,								
2	is amended by adding a new section to be appropriately									
3	designated and to read as follows:									
4	"§710- Obstruction of public administration; official									
5	misconduct. (1) A person commits the offense of official									
6	misconduct if:									
7	<u>(a)</u>	The person is a public servant;								
8	<u>(b)</u>	The person has reasonable suspicion to believe that a								
9		crime has been committed, is being committed, or is								
10		about to be committed by another public servant; and								
11	<u>(c)</u>	The person intentionally or knowingly fails to report								
12		promptly the crime that has been committed, is being								
13		committed, or is about to be committed to law								
14		enforcement authorities.								
15	(2)	The report required by subsection (1) shall include:								
16	<u>(a)</u>	The reporting person's name;								
17	<u>(b)</u>	The date, time, and place of the incident;								
18	(C)	The identity; and

1	<u>(d)</u>	The description of all participants and events									
2		amounting to a violation of subsection (1).									
3	(3)	The report shall be made:									
4	<u>(a)</u>	Within five days from the time the crime was committed									
5		or from the time the reporter knows about or should									
6		have known about the violation of subsection (1),									
7		whichever is later;									
8	<u>(b)</u>	In the case of a crime being committed, at the time									
9		the crime is being committed; and									
10	<u>(c)</u>	In the case of a crime that is about to be committed,									
11		prior to the commission of the crime, if the reporter									
12		knows about or should have known about the crime.									
13	(4)	A person acting in good faith shall be immune from any									
14	civil lia	bility for reporting a violation of subsection (1).									
15	(5)	Notwithstanding any law to the contrary, this duty									
16	shall exi	st, except that this section shall not require of a									
17	communica	tion that is privileged by law.									
18	(6)	Official misconduct is an offense of the same class									
19	and grade	as the most serious offense that has been committed,									
20	is being	committed, or is about to be committed."
