

A BILL FOR AN ACT

RELATING TO DAMS AND RESERVOIRS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 179D, Hawaii Revised Statutes, is 2 amended by adding two new sections to be appropriately 3 designated and to read as follows: 4 "§179D-Duty to control water level. The owner of a dam 5 or reservoir shall not allow the actual water level of the 6 reservoir to exceed the design water level. 7 Duty to maintain dam and reservoir. (a) §179D-The owner of a dam or reservoir shall have the duty to manage and 8 9 maintain the dam or reservoir in safe condition; provided that 10 this duty shall include, but not be limited to, keeping all 11 valves and spillways in working condition and preventing natural 12 and planted foliage, including but not limited to the foliage 13 roots, from compromising the safety of the dam or reservoir. 14 The owner shall have the duty to properly manage and (b) maintain each of the reservoir's water inlet and water outlet 15 16 points; provided that this management and maintenance shall

include but not be limited to annual cleanings."
