BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 171-18, Hawaii Revised Statutes, is
amended to read as follows:

3 "\$171-18 Public land trust. All funds derived from the 4 sale or lease or other disposition of public lands shall be 5 appropriated by the laws of the State; provided that all 6 proceeds and income from the sale, lease, or other disposition of lands ceded to the United States by the Republic of Hawaii 7 8 under the joint resolution of annexation, approved July 7, 1898 9 (30 Stat. 750), or acquired in exchange for lands so ceded, and 10 returned to the State of Hawaii by virtue of section 5(b) of the 11 Act of March 18, 1959 (73 Stat. 6), and all proceeds and income from the sale, lease or other disposition of lands retained by 12 13 the United States under sections 5(c) and 5(d) of the Act and later conveyed to the State under section 5(e) shall be held as 14 15 a public trust for the support of the public schools and other 16 public educational institutions, for the betterment of the conditions of native Hawaiians as defined in the Hawaiian Homes 17 18 Commission Act, 1920, as amended, for the development of farm HB LRB 07-1440.doc
