A BILL FOR AN ACT

RELATING TO JURORS AND PROSPECTIVE JURORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 612-2, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§612-2 Prohibition of discrimination. A citizen shall
- 4 not be excluded from jury service in this State on account of
- 5 race, color, religion, sex, national origin, economic status, or
- 6 [on account of a] physical [handicap] disability, except as
- 7 provided in section [612-4(3).] 612-4(b)(1)."
- 8 SECTION 2. Section 612-3, Hawaii Revised Statutes, is
- 9 amended as follows:
- 10 1. By adding three new definitions to be appropriately
- 11 inserted and to read:
- ""Circuit" refers to a judicial circuit, as specified in
- 13 section 603-1.
- 14 "Disability" means the state of having a physical or mental
- 15 impairment that substantially limits one or more of a person's
- 16 major life activities, having a record of such an impairment, or
- 17 being regarded as having such an impairment.
- 18 "Felony" means a crime as defined in section 701-107(2)."



- 1 2. By amending the definition of "clerk" to read:
- ""Clerk" and "clerk of the court" [include any deputy
- 3 clerk.] means the chief court administrator for a circuit, any
- 4 authorized deputy chief court administrator, and any other
- 5 person designated by the chief court administrator or the court
- 6 to perform the functions under this chapter."
- 7 3. By deleting the definition of "physical handicap".
- 8 [""Physical handicap" means a physical impairment which
- 9 substantially limits one or more of a person's major life
- 10 activities."]
- 11 SECTION 3. Section 612-4, Hawaii Revised Statutes, is
- 12 amended to read as follows:
- 13 "§612-4 Grounds of qualification and disqualification.
- 14 (a) A prospective juror is qualified to serve as a juror if the
- 15 prospective juror:
- 16 (1) Is a citizen of the United States and of the State $[\tau]$;
- 17 (2) Is at least eighteen years old[, and];
- 18 (3) Is a resident of the circuit; and
- 19 $\left[\frac{(2)}{(2)}\right]$ (4) Is able to read, speak, and understand the
- 20 English language.
- 21 (b) A prospective juror is disqualified to serve as a
- 22 juror if the prospective juror:



1	(1)	Is incapable, by reason of the prospective juror's
2		[physical or mental] disability, of rendering
3		satisfactory jury service; but a [person] prospective
4		juror claiming this disqualification may be required
5		to submit a physician's certificate as to the
6		disability, and the certifying physician is subject to
7		inquiry by the court at its discretion;
8	(2)	Has been convicted of a felony in a state or federal
9		court and not pardoned; or
10	(3)	Fails to meet the qualifications in subsection (a)."
11	SECT	ION 4. Section 612-7, Hawaii Revised Statutes, is
12	amended t	o read as follows:
13	" [【]	§612-7[+] Excused when, for cause. A prospective
14	juror sha	ll not be excused by a court for slight or trivial
15	cause, bu	t only when it appears that jury duty would entail a
16	serious personal hardship, or that for other good cause the	
17	prospective juror should be excused either temporarily or	
18	otherwise."	
19	SECT	TION 5. Section 612-8, Hawaii Revised Statutes, is to
20	read as follows:	
21	"§61	2-8 Pay of jurors; mileage fee; parking violations
22	exemption	. (a) Each juror or prospective juror shall be paid

- 1 \$30 for each day of actual attendance at court. In addition,
- 2 each juror or prospective juror shall be paid 33 cents for each
- 3 mile actually and necessarily traveled in going to and from
- 4 court. A person who appears at the time for which that person
- 5 is summoned to court for jury duty may be allowed the mileage
- 6 fee although the person, upon that person's request, is
- 7 subsequently excused or exempted from jury service.
- 8 (b) In the discretion of the court, any juror who incurs
- 9 expenses for transportation, board, and lodging as a result of
- 10 the distance the juror resides from the location of the court,
- 11 may be reimbursed for actual expenses.
- (c) All jurors or prospective jurors shall be exempt from
- 13 any prosecution, penalty, or fine as a result of a parking
- 14 violation committed in connection with the juror or prospective
- 15 juror appearing at court for jury duty; provided that the juror
- 16 or prospective juror shall present any parking citation received
- 17 during this time to the court clerk of the circuit court or
- 18 district court or the jury pool clerk, as appropriate, who shall
- 19 verify that the juror or prospective juror was serving on jury
- 20 duty or appearing in court in response to a summons for jury
- 21 duty at the time the citation was received. The clerk of the
- 22 circuit court or district court or the jury pool clerk, as



- 1 appropriate, shall keep an attendance roll in which shall be
- 2 entered each juror's or prospective juror's name, each date the
- 3 juror or prospective juror was summoned and appeared for jury
- 4 duty, and the date the juror or prospective juror was discharged
- 5 from service. The supreme court shall adopt rules necessary to
- 6 effect this section."
- 7 SECTION 6. Section 612-9, Hawaii Revised Statutes, is
- 8 amended to read as follows:
- 9 "[+] §612-9[+] Certificate for jury pay. At least once
- 10 each month, the clerk shall certify the number of days each
- 11 juror or prospective juror has attended court and the amount due
- 12 to the juror [. Each juror shall state on oath to the clerk the
- 13 number of miles traveled for which the juror is entitled to
- 14 mileage.] or prospective juror."
- 15 SECTION 7. Section 612-11, Hawaii Revised Statutes, is
- 16 amended by amending subsection (a) to read as follows:
- 17 "(a) Each year the clerk for each circuit shall compile a
- 18 master list. The master list shall consist of all voter
- 19 registration lists for the circuit, which shall be supplemented
- 20 with [names from] other lists of persons [resident therein]
- 21 residing in the circuit, such as lists of taxpayers and
- 22 [drivers' licenses. This includes names, addresses, and social



- 1 security numbers taken from income tax returns and estimates
- 2 notwithstanding section 235-116.] licensed drivers.
- 3 Notwithstanding any other law to the contrary, including section
- 4 235-116, the lists used to compile the master list shall contain
- 5 available identifying information of the persons on the list,
- 6 such as last name, first name, middle initial, date of birth,
- 7 gender, address, and social security number. Each person's name
- 8 shall appear only once on the master list."
- 9 SECTION 8. Section 612-13, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "§612-13 Juror qualification form. (a) The clerk shall
- 12 prepare an alphabetical list of the names in the master jury
- 13 wheel, which shall not be disclosed to any person other than
- 14 pursuant to this chapter or specific order of the court. The
- 15 clerk shall mail to every name on the list a juror qualification
- 16 form accompanied by instructions to fill out and return the form
- 17 by mail to the clerk within ten days after its receipt. The
- 18 form shall be subject to approval by the court [as to matters of
- 19 form] and shall elicit the name, address [of resident], and age
- 20 of the prospective juror, other information pertinent to
- 21 disqualification or exemption from jury service, and any other
- 22 matters as may be ordered by the court. The form also shall



- 1 contain the prospective juror's declaration that the prospective
- 2 juror's responses are true to the best of the prospective
- 3 juror's knowledge and the prospective juror's acknowledgment
- 4 that a wilful misrepresentation of a material fact may be
- 5 punished by a fine of not more than \$500 or imprisonment for not
- 6 more than thirty days, or both. Notarization of the juror
- 7 qualification form shall not be required. If the prospective
- 8 juror is unable to fill out the form, another person may do it
- 9 for the prospective juror and shall indicate that the person has
- 10 done so and the reason therefor. In any case in which it
- 11 appears that there is an omission, ambiguity, or error in a form
- 12 completed by a prospective juror, the clerk may return the form
- 13 with instructions to the prospective juror to make such
- 14 additions or corrections as may be necessary and to return the
- 15 form to the clerk within ten days after its receipt. Upon the
- 16 failure or refusal of any person duly receiving the juror
- 17 qualification form to complete and return it as required[, or in
- 18 case of an omission, ambiguity, or error in a returned form, or
- 19 instructed, the court, after first summoning the person to
- 20 appear before the clerk to complete or correct the form, may
- 21 punish the person for contempt.

- 1 At the time of the prospective juror's appearance for jury service, or at the time of any interview before the court 2 3 or clerk, any prospective juror may be required or permitted to fill out another juror qualification form in the presence of the 4 court or clerk, at which time the prospective juror may be 5 questioned, but only with regard to the prospective juror's 6 7 responses to questions contained on the form and grounds for the prospective juror's exemption, excuse, or disqualification. 8 information thus acquired by the court or clerk shall be noted 9 10 [on the juror qualification form]. 11 Any person who wilfully misrepresents a material fact on a juror qualification form for the purpose of avoiding or 12 13 securing service as a juror is guilty of a petty misdemeanor. 14 Juror qualification forms shall not be deemed a public (d) 15 record, nor shall they become part of the court record unless 16 the court so orders and places the forms under the seal of the 17 court; provided that [a redacted form] the contents of the completed juror qualification forms, redacted to exclude a 18 19 juror's social security number, driver's license number, home and business telephone numbers, street address, and other 20

- 1 (2) When permitted in accordance with section 612-23."
- 2 SECTION 9. Section 612-14, Hawaii Revised Statutes, is
- 3 amended to read as follows:
- 4 "§612-14 Qualified jury wheel. (a) Upon return of the
- 5 juror qualification forms, the clerk, after careful
- 6 investigation in each case, shall select for prospective jury
- 7 service all those persons whom the clerk believes are qualified
- 8 and not exempt; provided that any person who is exempt may be
- 9 selected if the person waives the person's exemption.
- 10 (b) The names of the persons so selected shall be placed
- 11 in the qualified jury wheel, to be used in compiling lists of
- 12 prospective jurors subject to service during the ensuing year;
- 13 provided that the clerk, with the approval of the court, may
- 14 excuse a prospective juror for any cause set forth under section
- 15 612-7, in which case the name of the excused person shall not be
- 16 placed in the qualified jury wheel.
- 17 (c) The clerk may place in the qualified jury wheel for
- 18 further service the name of any [juror] person who, in the
- 19 previous jury year, wilfully or without reasonable excuse failed
- 20 to appear as summoned."
- 21 SECTION 10. Section 612-15, Hawaii Revised Statutes, is
- 22 amended to read as follows:

    of each circuit shall make and file, not later than January 5,

    one or more certified lists of the names and addresses of [fifty

- 6 judges, at any time, for reasons appearing sufficient to the
- 7 judge or them, may order the dissolution of any certified list
- 8 of prospective grand or trial jurors and order the clerk to make
- 9 and file a new list, which may include any of the persons so
- 10 discharged, to serve for the remainder of the year. The new
- 11 list shall be compiled in the manner prescribed by the court.
- 12 Until the new list is filed, grand or trial jurors may be drawn
- 13 from a list thereof compiled and filed by the judge or judges
- 14 making the order or one or more of them designated by the
- 15 remainder, which list shall expire not later than thirty days
- 16 after the filing thereof unless the period is extended, except
- 17 that trial jurors may sit beyond the end of the period
- 18 prescribed in this subsection and after the filing of a new list
- 19 by the clerk, for the trial of any case in which the selection
- 20 of the jury has already commenced."
- 21 SECTION 11. Section 612-16, Hawaii Revised Statutes, is
- 22 amended to read as follows:



"§612-16 Grand jury. (a) The court shall order one or 1 more grand juries to be impaneled at such times as the public 2 interest requires; provided that there shall be an annual 3 4 initial impaneling not later than January 15. (b) For the impaneling of a grand jury, the prospective 5 jurors on a certified list of grand jurors shall be summoned and 6 the names of those who are present, and not disqualified, 7 exempted, or excused, shall be placed in an appropriate 8 container from which a drawing by lot shall be conducted in 9 order to draw a sufficient number of names to constitute a grand 10 jury. A sufficient number of additional names on a certified 11 list, as determined by the court, shall be drawn so that 12 alternate grand jurors may be designated to serve as grand 13 jurors in case of any vacancy occurring on a grand jury. 14 drawing shall be made in open court in the presence of the 15 judge, no earlier than one week after a publication of notice of 16 17 the time and place of drawing in a newspaper of general circulation published within the circuit for which the grand 18 jury is drawn; provided that if there is no such newspaper, then 19 after at least one week's posting of such notice in at least 20 21 three conspicuous places in the circuit.

1	(c) A certificate listing the names of the grand jurors		
2	and alternate grand jurors, and stating the essential facts of		
3	the drawing, signed by the judge and attested by the clerk,		
4	shall be filed.		
5	(d) The grand jury, being impaneled and sworn, shall be		
6	charged by the court. The alternate grand jurors shall also be		
7	sworn and charged by the court, but shall not be impaneled. In		
8	[doing so,] charging the grand jurors and alternate grand		
9	jurors, the court shall give them such information as it may		
10	deem proper as to their duties and as to the law pertaining to		
11	such cases as may come before them. The court may further		
12	charge the grand [jury] jurors and alternate grand jurors from		
13	time to time, as it may deem necessary.		
14	[(e) For the courts of the first circuit of the State from		
15	January 1, 1989, to December 31, 1991, and for the courts of all		
16	other circuits of the State from January 1, 1990, to December		
17	31, 1992, a grand jury shall serve for a period of six months		
18	after being impaneled; provided that a grand jury may:		
19	(1) Sit beyond such period to complete any matter in which		
20	the grand jury was impaneled;		
21	(2) Be discharged sooner by the court; and

         (e) Effective January 2, 1992, for the courts of the first

1 prospective trial jurors ordered by a judge shall be summoned to 2 attend and serve. The names of those summoned and present, and not disqualified, excused or exempted, shall be placed in an 3 appropriate container, from which there shall be drawn a 4 sufficient number of names to constitute a trial jury. The 5 6 drawing shall be by lot in open court under the supervision of 7 the judge. [There is no requirement that all names ordered by a 8 judge be exhausted before other names may be used in the 9 drawing, and the names of jurors which have been transmitted to 10 the judge may be mixed with each other in the container during the drawing.] If a jury cannot be chosen for the trial of a 11 case from the names placed in the container before the drawing 12 commenced, additional names may be placed in the container. For 13 14 this purpose, additional names may be ordered and randomly 15 selected from the certified list of prospective trial jurors, and the additional prospective jurors summoned. The judge may 16 **17** summon jurors from among bystanders on consent of all parties. 18 All names initially ordered by the judge need not be exhausted 19 before other names may be used in the drawing, and the names of 20 additional prospective jurors summoned and present may be added 21 to the container during the drawing.

 $[\frac{(d)}{(d)}]$ Prospective jurors in attendance, but not 1 2 actually serving in a trial before the judge, shall be subject to such orders relative to further jury service as the judge 3 deems appropriate, including service before other judges in the 4 5 circuit. 6 [(f)] (e) Each juror ordered by a judge shall serve for a period of one day, commencing from the first day the juror is 7 required to appear for service; provided that any juror may be 8 9 required to serve beyond the one-day period for the trial of any case in which the selection of the jury commenced within that 10 period. Upon completion of service by all jurors ordered by the 11 12 judge to serve, the jurors shall be returned to the clerk, who shall not transmit the jurors again to any judge until all other 13 jurors have been exhausted and other jurors which served at a 14 15 more remote time have been first transmitted for service. $\left[\frac{\langle q \rangle}{\langle q \rangle}\right]$ (f) A judge may, having regard to the equitable 16 distribution of jury service, excuse any juror after actual 17 service in a trial." 18 SECTION 13. Section 612-18, Hawaii Revised Statutes, is 19 20 amended by amending subsections (a) and (b) to read as follows:

"(a) If the court so orders, prospective trial jurors 1 shall be drawn[7] and summoned, and further proceedings had as 2 provided in section 612-17. 3 4 [If no order is made under subsection (a) in a (b) particular circuit, the judge (or judges, if there are more than 5 one) of that circuit may order a system of jury selection from 6 the certified list of trial jurors which is not contrary to the 7 general purposes of this chapter.] In no case shall the trial 8 jurors be chosen other than by lot, nor shall the trial jury be 9 selected from the prospective jurors other than by lot in open 10 court. [In selecting the trial jury there is no requirement 11 12 that all the names ordered by a judge be exhausted before other names may be used in the drawing, and the names of jurors may be 13 mixed with each other for the drawing.] " 14 SECTION 14. Section 612-19, Hawaii Revised Statutes, is 15 amended to read as follows: 16 "§612-19 Summoning of prospective jurors. (a) When so 17 ordered by the court, the clerk shall transmit to the chief of 18 police or a bailiff the names of prospective jurors to be 19 The chief of police or bailiff, either personally or 20 summoned. through an authorized subordinate, shall summon the persons 21

named to attend the court by giving personal notice to each of

- 1 the time and place of required appearance as fixed by order of
- 2 the court. The court may order the summoning of prospective
- 3 jurors by any officer of the court, and the service of summons
- 4 by any form of personal notice, including notice by telephone.
- 5 (b) A prospective juror who, wilfully or without
- 6 reasonable excuse, fails to attend after receipt of a summons by
- 7 the court may be arrested and punished for contempt.
- **8** (c) The clerk may place in the qualified jury wheel for
- 9 further service in the ensuing jury year the name of any
- 10 prospective juror who wilfully or without reasonable excuse
- 11 failed to attend after receipt of a summons by the court."
- 12 SECTION 15. Section 612-21, Hawaii Revised Statutes, is
- amended to read as follows:
- 14 "[+]§612-21[+] Jurors disqualified, exempted, or excused.
- 15 Whenever a juror has been disqualified, exempted, or excused,
- 16 that fact shall be noted [on the juror's juror qualification
- 17 form], and the juror shall not be subject to service for the
- 18 period of time commensurate with the nature and circumstances of
- 19 the juror's disqualification, exemption, or excuse."
- 20 SECTION 16. Section 612-22, Hawaii Revised Statutes, is
- 21 amended to read as follows:

1 "§612-22 Trial jurors subject to one year of service; one day or one trial requirement. The persons whose names are 2 placed on the certified lists of prospective trial jurors filed 3 by the clerk shall be subject to service for one year from and 4 after January 1 and until the filing of new certified lists; 5 provided that trial jurors shall serve only one day or one trial 6 during the year. Prospective jurors who are challenged at voir 7 dire and excused, excused for cause, summoned but not called to 8 a courtroom, or called to a courtroom but later excused shall 9 return to the juror pool to await reassignment to another trial. 10 [Jurors] Prospective jurors in the juror pool awaiting 11 reassignment to another trial shall be discharged after it has 12 been determined that their services will not be needed. 13 [Jurors] Prospective jurors who are discharged from the juror 14 pool shall be dismissed from service for the year; provided that 15 prospective jurors who fail to appear as summoned may have their 16 names placed in the qualified jury wheel for service in the 17 ensuing jury year and where a request for deferment of service 18 has been made and granted by the court, the period of time 19 between the first date of summons to appear and the time that 20 the prospective juror is next summoned for service may be tolled 21 and may be applied to extend the eligibility of service if the 22

- 1 prospective juror should not again be summoned or serve on an
- 2 actual trial within the year. [Jurors] Prospective jurors who
- 3 are accepted to serve on a jury shall complete the duration of
- 4 the trial and shall be dismissed from service for the year."
- 5 SECTION 17. Section 612-26, Hawaii Revised Statutes, is
- 6 amended to read as follows:
- 7 "§612-26 Use of electronic [or electromechanical devices]
- 8 or other means for drawing grand and trial juries. Selections
- 9 of citizens who are subject to jury duty and drawings of jury
- 10 lists, may be made by [means of] electronic [or
- 11 electromechanical devices commonly designated as data processing
- 12 equipment such as punch cards, electronic tape, random access
- 13 files, and other solid state devices when the same are available
- 14 for their use and the court so orders. data processing or any
- 15 other method to ensure random selection of jurors and implement
- 16 the purposes of this chapter."
- 17 SECTION 18. Section 612-27, Hawaii Revised Statutes, is
- 18 amended to read as follows:
- 19 "[+] §612-27[+] Rules. The supreme court is authorized to
- 20 adopt, amend, and repeal rules of court, not inconsistent with
- 21 the policies and objectives set forth in this chapter,
- 22 regulating all aspects of the selection and management of grand

- 1 and trial jurors[. The clerk, with the approval of the supreme
- 2 court, may adopt rules], and setting forth policies, procedures,
- 3 and forms for the selection and management of grand and trial
- 4 jurors in the jury pools, in courtrooms, and in other
- 5 appropriate circumstances in furtherance of the objectives of
- 6 this chapter."
- 7 SECTION 19. This Act shall not apply to proceedings that
- 8 commenced or were scheduled prior to its effective date, nor to
- 9 the qualification, selection, and summoning of persons subject
- 10 to jury service or serving as jurors for the 2007 calendar year.
- 11 This Act shall apply to the qualification, selection, summoning,
- 12 and service of persons for jury duty for proceedings commencing
- 13 or scheduled for the 2008 jury service year.
- 14 SECTION 20. Statutory material to be repealed is bracketed
- 15 and stricken. New statutory material is underscored.
