Section 323D-75, Hawaii Revised Statutes, is 1 SECTION 1. amended by amending subsections (a) and (b) to read as follows: 2 The attorney general shall conduct its review of the 3 "(a) application in accordance with the standards enumerated in 4 section 323D-76. Within ninety days after receipt of [an] a 5 complete application, the attorney general shall review and 6 approve or disapprove the acquisition. 7

If the attorney general does not act within ninety (b) 8 days after receipt of [an] a complete application, the 9 application shall be deemed approved. If the attorney general 10 approves or disapproves the acquisition, the applicant, or any 11 person who has submitted comments and has a legal interest in 12 the hospital being acquired or in another hospital that has 13 contracted with the acquired hospital for the provision of 14 essential health services, may bring an action for declaratory 15 judgment for a determination that the acquisition is or is not 16

JUSTIFICATION SHEET

Attorney General DEPARTMENT:

A BILL FOR AN ACT RELATING TO THE REVIEW OF TITLE: HOSPITAL ACQUISITIONS BY THE ATTORNEY GENERAL.

The purpose of this bill is to amend section PURPOSE: 323D-75, Hawaii Revised Statutes, to clarify that the deadline for the Attorney General to review and either approve or disapprove an application for the acquisition of a hospital is ninety days after the submission of a complete application.

Amend section 323D-75(a) and (b), Hawaii MEANS: Revised Statutes.

Under subsection (c) of section 323D-75, the JUSTIFICATION: State of Hawaii Health Planning and Development Agency has ninety days to make a decision on a certificate of need application after submission of a complete application, but the statute says that the Attorney General must decide within ninety days of receiving an application, which may or may not be complete.
