TITLE:

A BILL FOR AN ACT RELATING TO ENVIRONMENTAL SITE CLEANUP.

PURPOSE:

To repeal the sunset date of the Hawaii brownfields revolving loan fund to enable the State to continue to offer low-cost loans to enable eligible borrowers for the cleanup of contaminated properties.

MEANS:

Amend Act 173, Session Laws of Hawaii 2002.

JUSTIFICATION:

The Hawaii brownfields cleanup revolving loan fund offers low-cost cleanup loans to redevelopers of environmentally contaminated sites. The revolving loan fund is capitalized with \$1.9 million in funds from an Environmental Protection Agency grant. Act 173 which establishes the revolving loan fund sunsets June 30, 2007. The Department of Business, Economic Development, and Tourism is currently reviewing its first loan application request for approximately \$950,000. The repeal is necessary to allow the program to continue to offer loans and receive repayments.

Impact on the public: Public health will be favorably impacted by the clean up of contaminated sites. The blighted areas will be redeveloped into economically and socially beneficial uses including but not limited to housing, commercial and retail buildings, and open space.

Impact on the department and other agencies: The bill will allow the program to continue to offer loans. The loans will result in the clean up of contaminated sites and the reuse of these sites for such uses as housing, commercial



and retail buildings, and open space. These uses, particularly the business uses, contribute to the department's economic development goals.
