RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 206E-14, Hawaii Revised Statutes, is
- 2 amended by amending subsection (b) to read as follows:
- 3 "(b) In the case of residential projects or redevelopment
- 4 projects, the terms of the sale shall provide for the repurchase
- 5 of the property by the authority at its option, in the event
- 6 that the purchaser, if other than a state agency, desires to
- 7 sell the property [within ten years,]; provided that this
- 8 requirement may be waived by the authority if the authority
- 9 determines that a waiver will not be contrary to the community
- 10 development plan. The authority shall establish at the time of
- 11 original sale a formula setting forth a basis for a repurchase
- 12 price based on market considerations including but not being
- 13 limited to interest rates, land values, construction costs, and
- 14 federal tax laws.
- 15 If the purchaser in a residential project is a state
- 16 agency, the authority may include as a term of the sale a
- 17 provision for the repurchase of the property in conformance with
- 18 this section."
