## A BILL FOR AN ACT

ESTABLISHING A COMMISSION TO PLAN FOR THE FIFTIETH ANNIVERSARY OF HAWAII STATEHOOD.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to create a
- 2 commission composed of members from a wide range of Hawaii's
- 3 communities to plan and coordinate the public celebration of the
- 4 fiftieth anniversary of Hawaii's admission to statehood in the
- 5 United States of America.
- 6 The legislature finds and declares that the appropriation
- 7 under this Act is in the public interest and would benefit the
- 8 residents of Hawaii.
- 9 SECTION 2. (a) There is established a temporary
- 10 commission to be known as the fiftieth anniversary of statehood
- 11 commission consisting of twenty-five members who shall be
- 12 selected as provided in this Act, without regard to section
- 13 26-34, Hawaii Revised Statutes.
- 14 (b) The commission shall be placed within the office of
- 15 the governor for administrative purposes and shall cease to
- 16 exist after December 31, 2009.

- 1 admission of Hawaii to statehood, including a series of events
- 2 scheduled for August 2009, and shall submit to the legislature,
- 3 no later than twenty days prior to the convening of the regular
- 4 session of 2009, a written report of its recommendations,
- 5 including the following:
- 6 (1) A detailed plan on how to execute its recommendations;
- 7 and
- 8 (2) Identifying and recommending procedures for the
- 9 appropriate disbursal of any public funds.
- 10 SECTION 4. The chair of the commission shall be selected
- 11 by the commission members. Members of the commission may elect
- 12 any subordinate officers that the commission deems appropriate
- 13 among the members but, at a minimum, shall elect a vice chair,
- 14 vice chair for finance, and vice chair for events.
- 15 SECTION 5. A vacancy on the commission shall be filled by
- 16 the same selection authority that appointed the vacating member.
- 17 SECTION 6. Commission members shall serve on a voluntary
- 18 basis without compensation, but shall be entitled to
- 19 reimbursement for necessary expenses, including travel expenses,
- 20 for attending commission meetings and while in the discharge of
- 21 their duties and responsibilities under this Act.

- 1 SECTION 7. Fifteen members shall constitute a quorum to do
- 2 business. An affirmative vote of thirteen members shall be
- 3 necessary to make decisions. The commission's meeting schedule
- 4 shall be determined by the commission members.
- 5 SECTION 8. There is appropriated out of the tourism
- 6 special fund the sum of \$100,000 or so much thereof as may be
- 7 necessary for fiscal year 2007-2008 to be used by the commission
- 8 for the purposes of this Act.
- 9 The sum appropriated shall be expended by the Hawaii
- 10 tourism authority for the purposes of this Act.
- 11 SECTION 9. Any provision of this Act to the contrary
- 12 notwithstanding, the appropriation authorized under this Act
- 13 shall not lapse at the end of the fiscal year for which the
- 14 appropriation is made; provided that any unexpended and
- 15 unencumbered balance of the appropriation made in this Act as of
- 16 the close of business on December 31, 2009, shall lapse.
- 17 SECTION 10. This Act shall take effect upon its approval;
- 18 provided that section 8 shall take effect on July 1, 2007.
