A BILL FOR AN ACT

RELATING TO THE STATE PHARMACY ASSISTANCE PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Prescription drugs have become an increasingly
- 2 important part of health care, especially among older adults.
- 3 Prescription drugs have also become the most expensive component
- 4 of health care, accounting for approximately two-thirds of
- 5 health care costs.
- In 2002, the legislature adopted the Hawaii Rx program,
- 7 intended to help a large population of Hawaii residents better
- 8 afford their prescription drugs through a discount program,
- 9 thereby increasing the overall health of Hawaii residents,
- 10 promoting healthy communities, and protecting public health and
- 11 welfare. In 2004, the program was amended to become the Hawaii
- 12 Rx plus program. Implemented in July 2005, Hawaii Rx plus has
- 13 enabled thousands of Hawaii residents, regardless of age, to
- 14 take advantage of discounted prices for their prescription drug
- 15 needs when no other insurance or payor are available to them.
- In 2005, in anticipation of the new Medicare Modernization
- 17 Act's Part D program which took effect on January 1, 2006, the
- 18 State medicare part D state pharmacy assistance program was

- 1 created. The State medicare part D program covers the co-
- 2 payments for medicare and medicaid dual eligible clients to
- 3 ensure a smooth transition of prescription drug coverage from
- 4 medicaid to medicare.
- 5 The federal Medicare Modernization Act of 2005 also
- 6 provides special relief for qualified state pharmacy assistance
- 7 programs. Both the Hawaii Rx plus program and the State
- 8 Medicare part D program are recognizable under federal law as
- 9 state pharmacy assistance programs and, if they are combined
- 10 under an umbrella program and approved as a single federally
- 11 recognized program, could receive enhanced benefits from the
- 12 federal Centers for Medicare and Medicaid Services.
- 13 This bill would consolidate the provisions of both the
- 14 Hawaii Rx plus program and the State Medicare part D program
- 15 into a single state pharmacy assistance program for which the
- 16 State could then seek approval from the federal Centers for
- 17 Medicare and Medicaid Services to recognize this newly
- 18 consolidated program as a federally qualified state pharmacy
- 19 assistance program to receive enhanced benefits.
- 20 Through this consolidation, the State Medicare part D
- 21 program would remain the same and its enrollees would be
- 22 identified as "tier one enrollees" and the Hawaii Rx plus

- 1 program would remain the same and its enrollees would be
- 2 identified as "tier two enrollees". In addition, this bill
- 3 would provide prescription drug assistance for a subset of the
- 4 Hawaii Rx plus population, identified as the "tier three
- 5 enrollees", who may be at risk of becoming medicaid eligible and
- 6 for whom the State will seek approval from the federal Centers
- 7 for Medicare and Medicaid Services to allow the mandating of
- 8 rebates from drug manufacturers resulting in greater discounts.
- 9 The State of Hawaii will continue to receive pharmacy
- 10 discounts for individuals in the Hawaii Rx plus program with
- incomes up to 350 per cent of the federal poverty level. With
- 12 federal Centers for Medicare and Medicaid Services approval, the
- 13 State will also be able to begin mandating rebates from
- 14 pharmaceutical companies for prescription drugs purchased by
- 15 individuals in the Hawaii Rx plus program who are at risk of
- 16 qualifying for medicaid with incomes equal to or less than 300
- 17 per cent of the federal poverty level as approved by the federal
- 18 Centers for Medicare and Medicaid Services.
- 19 The State of Hawaii may also be able to combine the
- 20 purchasing power of these two programs to negotiate larger
- 21 discounts, similar to federal government and private health
- 22 insurers, as approved by the federal Centers for Medicare and

- 1 Medicaid Services. Finally, combining both programs into a
- 2 federally qualified state pharmacy assistance program
- 3 streamlines operations and promotes effective administration.
- 4 The federal Centers for Medicare and Medicaid Services is
- 5 requiring a State statute before they will consider a request
- 6 for approval of the income eligibility for the medicaid at-risk
- 7 population and set the percentage of State contribution that
- 8 will be required towards the cost of the prescription drugs for
- 9 the at-risk population which will allow the mandating of rebates
- 10 for this group.
- 11 This bill, to be known as the "Hawaii Prescription Drug
- 12 Affordability Act of 2007", seeks to further drive down the cost
- 13 of prescription drugs for Hawaii's uninsured, underinsured, low-
- 14 income, elderly and disabled residents.
- 15 SECTION 2. Chapter 346, Hawaii Revised Statutes, is
- 16 amended by adding a new section to be appropriately designated
- 17 and to read as follows:
- 18 "§346- Program goals. The legislature finds that
- 19 affordability is critical in providing Hawaii residents with
- 20 access to prescription drugs. This part is enacted by the
- 21 legislature to enable the State to make prescription drugs more
- 22 affordable for qualified Hawaii residents and thereby increase

- 1 the overall health of Hawaii residents, promote healthy
- 2 communities, and protect the public health and welfare. The
- 3 legislature also intends that the program be integrated as much
- 4 as possible with other state health programs. It is not the
- 5 intention of the legislature for this law to discourage
- 6 employers from offering to pay, or from paying for prescription
- 7 drug benefits for their employees, or to supplant employer-
- 8 sponsored prescription drug benefit plans."
- 9 SECTION 3. Chapter 346, Hawaii Revised Statutes, is
- 10 amended by adding a new section to be appropriately designated
- 11 and to read as follows:
- 12 "§346- Hawaii Rx plus preferred drug list. (a) All drugs
- 13 shall be available at the medicaid discount price, or less. The
- 14 Hawaii Rx plus preferred drug list shall offer an additional
- 15 "secondary discount price," or less, on preferred drugs, to be
- 16 reimbursed through the Hawaii state pharmacy assistance program
- special fund.
- 18 (b) The department shall establish secondary discounts for
- 19 drugs covered by a rebate agreement and shall promote the use of
- 20 safe, efficacious, and cost-effective drugs, taking into
- 21 consideration:

(5) 5 When considering categories of drugs designed to treat specialized chronic medical conditions and diseases, the 6 7 committee shall consult with physicians and other health care professionals with specialized clinical knowledge and expertise 8 9 in this area, either in their capacity as consultants serving on 10 a subcommittee of the committee, or as physicians or pharmacists 11 with a practice or specialty in chronic diseases. 12 (f) The determination of a drug's safety and efficacy shall be consistent with the standards set forth in the peer-13 reviewed literature and other available sources, including but 14 15 not limited to: 16 (1) The American Hospital Formulary Service Drug 17 Information; 18 (2) The United States Pharmacopoeia Drug Information; 19 (3) The DRUGDEX System; and The American Medical Association Drug Evaluations. 20 (4) 21 The determination of a drug's net cost shall consider (q) 22 the pharmacy reimbursement amount authorized under section

- 6 SECTION 4. Chapter 346, Hawaii Revised Statutes, is
- 7 amended by adding a new section to be appropriately designated
- 8 and to read as follows:

- 10 and labelers. (a) The names of manufacturers that enter and do
- 11 not enter into rebate agreements pursuant to this part shall be
- 12 deemed public information. The department shall release this
- information to health care providers and the public.

- 15 health care providers information about the relative cost of
- 16 drugs produced by manufacturers that enter into rebate
- 17 agreements compared to the cost of drugs produced by those that
- do not enter into rebate agreements, as allowed by law."
- 19 SECTION 5. Chapter 346, Hawaii Revised Statutes, is
- 20 amended by adding a new section to be appropriately designated
- 21 and to read as follows:

16	retail pharmacy located in this State, or another business
17	licensed to dispense prescription drugs in this State, that
18	elects to participate in the program.
19	"Pharmacy and therapeutic committee" means the committee
20	established by the department that advises the state medicaid
21	director on the Hawaii Rx plus preferred drug list.

Provided that there are no 8 federally approved prescription drug plans available in the 9 state that provide a full coverage prescription drug benefit, 10 the [state pharmacy assistance program] state medicare part D 11 program may coordinate the prescription drug coverage with [the] any benchmark federal medicare part D prescription drug plan 12 benefit, including related supplies, as determined by the 13 department, to each resident who meets the eligibility 14 requirements as outlined in section 346-343. The Hawaii Rx plus 15 16 program shall combine the purchasing power of all qualified residents to enable the State to reduce prescription drug costs, 17 18 as approved by the federal Centers for Medicare and Medicaid Services, and further improve the quality of healthcare for 19 qualified Hawaii residents in the program, thereby increasing 20 21 the overall health of Hawaii residents, promoting healthy 22 communities, and protecting the public health and welfare.

There is appropriated out of the Hawaii state pharmacy 8 9 assistance program special fund the sum of \$50,000, or so much thereof as may be necessary for fiscal year 2007-2008, to the 10 department of human services for the purposes of conducting the 11 study mandated in Section 14 of this Act. 12 The sum appropriated by this Act shall be expended by the 13 department of human services for the purposes of conducting the 14 15 study mandated in Section 14 of this Act. 16 SECTION 16. A BILL FOR AN ACT RELATING TO THE STATE PHARMACY ASSISTANCE PROGRAM.

PURPOSE:

The purpose of this bill is to create a comprehensive Hawaii State Pharmacy Assistance program by merging the current State Pharmacy Assistance program which coordinates the Medicare Part D drug benefit and the Hawaii Rx Plus program under a single comprehensive Hawaii State Pharmacy Assistance program umbrella. This will provide a mechanism to pursue deeper discounts through potential manufacturer rebates and other means. This bill will also make other housekeeping amendments to both programs.

This bill also requires the department to conduct a study in order to gather information on the size of the target population, utilization data and other information as needed in order for the department to identify the amount of the appropriation needed to implement the secondary discount price and other costs of the program; the bill provides for an appropriation for the study.

MEANS:

Add four new sections to chapter 346, amend sections 346-341, -342, -343, -344, and -345, and repeal Part XIII, Hawaii Revised Statutes.

JUSTIFICATION:

The current high costs of prescription drugs put people at-risk of eventually needing Medicaid assistance to cover these and other health care costs. Persons who are not currently eligible for Medicaid may become eligible as their medical expenses increase. Individuals up to 350 per cent of the federal poverty level will be eligible for this program, unless

otherwise approved by the federal Centers for Medicare and Medicaid Services (CMS).

This bill proposes to consolidate the provisions of both the Hawaii Rx plus program and the current State Pharmacy Assistance program, which coordinates the Medicare Part D drug benefit, into a single state pharmacy assistance program for which the State could then seek approval from CMS to recognize this newly consolidated program as a federally qualified state pharmacy assistance program to receive enhanced benefits.

Through this consolidation, the current State Pharmacy Assistance program, which coordinates the Medicare Part D drug benefit, would remain the same and its enrollees would be identified as "tier one enrollees" and the Hawaii Rx plus program would remain the same and its enrollees would be identified as "tier two enrollees". In addition, this bill would provide prescription drug assistance for a subset of the Hawaii Rx plus population, identified as the "tier three enrollees", who may be at risk of becoming medicaid eligible and for whom the State will seek approval from CMS to allow the mandating of rebates from drug manufacturers resulting in greater discounts.

This bill will provide for deeper discounts for prescription drugs through a manufacturer's supplemental rebate program. The State will also be partnering in a national multi-state drug pool to get the supplemental rebates from prescription drug manufacturers as approved by CMS.

This program will require approval by CMS and has to be established as a federally recognized state pharmacy assistance program. CMS is requiring a State statute before they will consider a request for

approval of the income eligibility for the medicaid at-risk population and set the percentage of State contribution that will be required towards the cost of the prescription drugs for the at-risk population which will allow the mandating of rebates for this group.

This enabling legislation will help the State in negotiations with CMS for approval.

Impact on the public: Individuals in the Hawaii Rx plus program with incomes up to 350 per cent of the federal poverty level, will continue to receive the initial discount price for their prescription drug purchases. Individuals at-risk of becoming Medicaid clients under the current Hawaii Rx Plus program (incomes up to 300 per cent of the federal poverty level as to be later approved by the federal Centers for Medicare and Medicaid Services), get greater help in paying for their prescription drugs so they will be able to maintain their health and avoid or delay the need for Medicaid because the State will be able to mandate manufacturers rebates for this group. Medicare Part D enrollees will continue to have their co-payments covered by State funds and will not be impacted by the rebate portion of this amended State Pharmacy Assistance program.

Impact on the department and other agencies: This bill will prevent or defer at-risk individuals from coming into Medicaid and will prevent increased health care costs to the State in the long-term.
