TITLE:

A BILL FOR AN ACT RELATING TO CORRECTIONAL

INDUSTRIES.

PURPOSE:

To allow State-employed adult corrections officers to purchase uniforms and uniform accessories from Correctional Industries.

MEANS:

Amend section 354D-4, Hawaii Revised

Statutes.

JUSTIFICATION:

Correctional Industries is the sole provider of adult corrections officer uniforms. In accordance with the United Public Workers Unit 10 contract, Section 22 (Uniforms), Adult Corrections Officers (ACO) are responsible for twenty-five percent of the cost of replacing State-issued uniforms and uniform accessories. This proposal will allow Correctional Industries to collect uniform payments directly from ACOs.
