### A BILL FOR AN ACT

RELATING TO LEGISLATIVE VACANCIES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 17-1, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "\$17-1 United States senator. When a vacancy occurs in
- 4 the office of United States senator the vacancy shall be filled
- 5 for the unexpired term at the following state general election,
- 6 provided that the vacancy occurs not later than 4:30 p.m. on the
- 7 sixtieth day prior to the primary for nominating candidates to
- 8 be voted for at the election; otherwise at the state general
- 9 election next following. The chief election officer shall issue
- 10 a proclamation designating the election for filling the vacancy.
- 11 Pending the election, the governor shall make a temporary
- 12 appointment to fill the vacancy [and the] by selecting a person
- 13 from a list of three prospective appointees submitted by the
- 14 same political party as the prior incumbent. The person [so]
- 15 appointed shall serve until the election and qualification of
- 16 the person duly elected to fill the vacancy and shall be, at the
- 17 time of appointment, and shall have been, for at least six
- 18 months immediately prior to the appointment, a registered member

15	days following the first day of vacancy to fill the vacancy for
16	the unexpired term [and the appointee shall be of] by selecting
17	a person from a list of three prospective appointees submitted
18	by the same political party or nonpartisanship as the [person
19	the appointee succeeds.] prior incumbent. The prospective
20	appointees shall be at the time of appointment, and shall have
21	been, for at least six months immediately prior to the
22	appointment, registered members of the political party. The

- 1 political party shall submit the list of prospective appointees
- 2 to the governor within thirty calendar days following the first
- 3 day of vacancy.
- 4 (b) If the prior incumbent was not a member of any

- 7 is not and has not been, for at least six months immediately

- 12 SECTION 5. This Act shall take effect upon its approval.

### Report Title:

Legislative Vacancies

### Description:

Requires the governor, in filling vacancies in the senate, house of representatives, and U.S. Senate, to select from a list of three prospective appointees nominated by the political party of the prior incumbent. Requires prospective appointees to be registered members of nominating political parties for at least six months prior to the appointment. Effective on approval.
