A BILL FOR AN ACT

RELATING TO GENETICALLY MODIFIED ORGANISMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 321-11.6, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"[+] $321-11.6[+]$ Genetically modified organisms[-];
4	notification and certification. (a) Any person that proposes
5	to research, test, propagate, cultivate, grow, or produce any
6	genetically modified organism shall:
7,	(1) Notify the department of the person's intent to

- 8 conduct the activity; and
- 9 (2) Obtain certification of approval from the department
 10 prior to conducting the activity.
- 11 (b) The department shall examine and evaluate each
- 12 proposed genetically modified organism research project;
- 13 testing, propagating, cultivating, or growing technique; or

14 product for its risk to public health and to the environment.

- 15 The department shall issue a certification of approval after
- 16 determining the level of risk of the genetically modified
- 17 organism-related activity in three areas: the risk to the

2	the risk	of consuming the genetically modified organism if it is
3	intended	for consumption.
4	The	certification of approval shall include information on:
5	(1)	The person or company proposing to conduct the
6		genetically modified organism-related activity;
7	(2)	The purpose of the genetically modified organism-
8		related activity;
9	(3)	What organism will be researched, tested, cultivated,
10		propagated, grown, or produced;
11	(4)	How many organisms will be researched, tested,
12		cultivated, propagated, grown, or produced;
13	(5)	The location of the genetically modified organism-
14		related activity; and
15	(6)	Any other information the department may deem
16		necessary.
17	<u>A11</u>	certifications of approval shall be available to the
18	public at	the department's office or on the department's
19	website.

1	genetically modified organisms shall submit one copy of that
2	application to the department, at the same time that the
3	application is submitted to the federal agency.
4	(d) Any person that researches, tests, propagates,
5	cultivates, grows, or produces any genetically modified organism
6	shall be civilly liable for injury or damage resulting from such
7	activity. Damage includes but is not limited to:
8	(1) Adverse effects on other crops;
9	(2) Adverse effects on the health of individuals exposed
10	to the genetically modified organism; and
11	(3) Adverse effects on the environment.
12	(e) The department shall adopt rules pursuant to chapter
13	91 to implement this section.
14	(f) As used in this section:
15	"Genetically modified organism" means a life form or its
16	living progeny that has been altered at the nucleic acid level,
17	using the techniques collectively referred to as recombinant DNA
18	technology.
19	"Person" means an individual, corporation, partnership,
20	limited liability corporation, or any other legal entity.
21	"Recombinant DNA technology" means the transfer of genes,
22	regulatory sequences, or nucleic acid between hosts by the use

1	of vectors or laboratory manipulations and include the
2	insertion, excision, duplication, inactivation, or relocation of
3	specific genes, regulatory sequences, or sections of nucleic
4	acid. This term does not apply to material or an organism
5	developed exclusively through traditional methods of breeding,
6	hybridization, or nondirected mutagenesis."
7	SECTION 2. Statutory material to be repealed is bracketed
8	and stricken. New statutory material is underscored.
9	SECTION 3. This Act shall take effect upon its approval.

Report Title:

Genetically Modified Organisms; DOH Notification and Certification; Risk Assessment; Liability

Description:

Requires persons proposing to engage in testing, propagating, cultivating, and growing GMOs to notify DOH and obtain a certification of approval from DOH. Requires DOH to determine the level of risk involved before issuing certification of approval. Includes liability provisions for injury or damage resulting from such activity.
