A BILL FOR AN ACT

RELATING TO PUBLIC MEETINGS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 92, Hawaii Revised Statutes, is amended 2 by adding three new sections to be appropriately designated and to read as follows: 3 "§92- Neighborhood board; notice and agenda; public 4 5 input; quorum. (a) Any contrary provision in this chapter notwithstanding, the provisions of this section shall apply to 6 neighborhood boards overseen by the neighborhood commission of 7 the city and county of Honolulu. 8 9 The agenda required to be included in written public 10 notice of a neighborhood board meeting may include an 11 opportunity for the board to receive public input on issues not 12 specifically noticed for consideration at the forthcoming 13 meeting. 14 (c) Any matter raised as part of the public input agenda 15 allowed under subsection (b) may be discussed and information on 16 the matter may be received by the board at the meeting; provided

that the board may not make a decision relating to the matter.

- 4 (d) A quorum for a meeting of a neighborhood board shall
- 5 be required to conduct official board business or for the

- 9 information or testimony on a matter of official board business
- 10 without a quorum; provided that the board may not make a

- 13 members. (a) Two or more members of a neighborhood board, but
- 14 less than the number of members necessary to constitute a quorum
- 15 for the board, may attend informational meetings or
- 16 presentations on matters relating to official board business,
- 17 including meetings of another entity, seminars, and community
- 18 meetings; provided that the presentation is not specifically and
- 19 exclusively organized for or directed toward members of the

- 21 (b) Neighborhood board members may participate in

- 1 that the discussions occur during and as part of the
- 2 informational meeting or presentation allowed by subsection (a),
- 3 and provided further that there is no deliberation or commitment
- 4 relating to a vote on the issue. The board members, at the next
- 5 duly noticed meeting of the neighborhood board, shall report
- 6 their attendance and the matters presented and discussed that
- 7 related to official board business at the informational meeting
- 8 or presentation.
- 9 §92- Neighborhood board meeting; unanticipated events;
- 10 public interest. For purposes of this section, an unanticipated
- 11 event that occurs after public notice of a neighborhood board
- 12 meeting has been issued but before the scheduled meeting, may be
- 13 the subject of discussion and deliberation at the scheduled
- 14 meeting if timely action on the matter is necessary for public
- 15 health, welfare, and safety. At a duly noticed meeting, a board
- 16 may take action on an unanticipated event in the public interest
- 17 that is not on the agenda in the same manner as if the board had
- 18 held an emergency meeting pursuant to section 92-8 to take
- 19 action on the issue."
- 20 SECTION 2. New statutory material is underscored.
- 21 SECTION 3. This Act shall take effect on January 1, 2112.

Description:

Authorizes public input at noticed neighborhood board meetings and discussion but not decisionmaking on those issues. Allows two or more neighborhood board members, but less than a quorum, to attend meetings relating to board business. Clarifies neighborhood board actions on unanticipated events. (HB1512 HD1)
