RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 264, Hawaii Revised Statutes, is
2	amended by adding a new section to part I be appropriately
3	designated and to read as follows:
4	"§264- Emergency powers; traffic emergency zones. (a)
5	Notwithstanding any other law to the contrary, if the governor
6	or the director determines that substantial endangerment to
7	public health and safety is or will be caused by the temporary
8	closure of, or the lack of adequate access to, an area by a
9	state highway as defined under section 264-1(a), which requires
10	immediate action, the governor or director, without a public
11	hearing, may designate the area to be a traffic emergency zone,
12	and may take any and all other actions as may be necessary until
13	access to the designated area has been established. The
14	designation shall fix a place and time, not later than twenty-
15	four hours thereafter, for a hearing to be held before the
16	director.

department of transportation, or a county, shall not give rise 1 2 to a cause of action or claim against: 3 (1) The State; The department of transportation; 4 (2) 5 (3) The counties; 6 Any owner of cane haul roads designated as state (4)7 highways under section 264- (b)(3); or 8 (5) Any officer, employee, or agent of an entity listed in 9 paragraphs (1) to (4). 10 (d) For the purposes of this section: "Cane haul roads" means an agricultural system of roads or 11 ways established to take agricultural products from the fields 12 13 to processing facilities without using the public highways. 14 "Traffic emergency zone" means an area that is accessible by a single state highway and whose accessibility would be 15 16 compromised by major motor vehicle accidents, fires, floods, 17 erosion, or other factors that would cause the closure of the 18 state highway."
