A BILL FOR AN ACT

RELATING TO LEGISLATIVE SERVICE AGENCIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 23-8, Hawaii Revised Statutes, is 1 2 amended to read as follows: "§23-8 Assistance and staff. (a) In the performance of 3 the auditor's duties, the auditor may employ the services of one 4 or more certified public accountants or accounting firms, and 5 other assistants and clerical workers as may be necessary; 6 provided the cost thereof shall not exceed the sums as may be 7 available out of the appropriation provided by law for the 8 conduct of the auditor's office; provided further that the accountants, firms, and assistants are entirely independent of 10 the departments, offices, and agencies of the State and its 11 political subdivisions whose affairs are subject to audit by the 12 auditor. 13 (b) All employees shall be hired by the auditor subject to 14 the approval of the president of the senate and the speaker of 15 the house of representatives and shall serve at the auditor's 16 pleasure; provided that in the establishment of the salary of 17 each employee, the auditor shall consult with the department of 18
