## A BILL FOR AN ACT

RELATING TO MARIJUANA POSSESSION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that scarce resources are 2 currently expended by county and state law enforcement entities 3 and judicial and detention facilities for enforcing marijuana 4 possession laws. Amending the State's marijuana laws to make 5 possession of less than one ounce a violation would permit law enforcement to focus their resources on more serious drug 6 7 issues, such as combating the ongoing ice epidemic. The 8 legislature has previously classified simple possession of 9 marijuana as a petty misdemeanor due to the relatively harmless 10 nature of this substance compared to other commonly used illegal 11 substances. While no psychoactive substance is completely 12 without risk, many scientists concur with drug enforcement 13 administration Judge Francis Young, who, in 1988, found that 14 "marijuana is one of the safest therapeutically active 15 substances known to man."

16 Current Hawaii law provides for a sentence of not more than 17 thirty days for possession of less than an ounce of marijuana. 18 Even a petty misdemeanor, however, is a crime. The criminal HB LRB 07-1656-1.doc

1 record thus incurred may impact arrestees' futures by rendering 2 them ineligible for federal college loans, certain types of 3 employment, and military service. Twelve other states have 4 recognized the advantages of downgrading possession of small 5 amounts of marijuana to a violation instead of a crime. These states--Alaska, California, Colorado, Maine, Minnesota, 6 7 Mississippi, Nebraska, Nevada, New York, North Carolina, Ohio, 8 and Oregon--have not experienced disproportionate spikes in 9 marijuana use since the enactment of these laws. According to a 1999 report by the National Academy of Sciences, Institute of 10 11 Medicine, entitled "Marijuana and Medicine: Assessing the 12 Science Base", "[i]n sum, there is little evidence that decriminalization of marijuana use necessarily leads to a 13 14 substantial increase in marijuana use."

Given that the vast majority of possession charges under the criminal code are dealt with by fines in any event, treating possession of less than an ounce of marijuana as a violation, punishable by a fine, provides some deterrence and demonstrates our State's disapproval of the use of the drug while imposing a penalty that is proportional to the offense.

5	SECTION 2. Chapter 712, Hawaii Revised Statutes, is
6	amended by adding a new section to be appropriately designated
7	and to read as follows:
8	"§712- Possession of marijuana. Possession of less
9	than one ounce of marijuana by an adult is a violation and shall
10	be subject to a fine of not more than \$ ."

12	amended by amending the definition of "detrimental drug" to read

16	chapter 329, or any marijuana $[-]$ ; provided that, for purposes of
17	section 712- , marijuana shall not be deemed a detrimental
18	drug."
19	SECTION 4. Section 712-1249, Hawaii Revised Statutes, is
20	amended by amending subsection (1) to read as follows:
21	"(1) [A] Except for possession of less than one ounce of

1 a detrimental drug in the third degree if the person knowingly 2 possesses any marijuana or any Schedule V substance in any 3 amount." 4 SECTION 5. This Act does not affect rights and duties that matured, penalties that were incurred, and proceedings that were 5 6 begun, before its effective date. 7 SECTION 6. Statutory material to be repealed is bracketed 8 and stricken. New statutory material is underscored. 9 SECTION 7. This Act shall take effect upon its approval. 10
