### A BILL FOR AN ACT

RELATING TO CRIME.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1	. Chapter 707, Hawaii Revised Statutes, is
2	amended by add	ing a new section to part IV to be appropriately
3	designated and	to read as follows:
4	" <u>§707–</u>	Human trafficking. (1) A person commits the
5	offense of hum	an trafficking if the person:
6	<u>(a)</u> Know	ingly subjects or attempts to subject another
7	pers	on to labor or services by:
8	<u>(i)</u>	Causing or threatening to cause serious bodily
9		injury to any person;
10	(ii)	Restraining or threatening to restrain another
11		person;
12	<u>(iii)</u>	Causing or threatening to cause a penal charge to
13		be instituted against another person;
14	(iv)	Knowingly destroying, concealing, removing,
15		confiscating, or possessing any actual or
16		purported passport or other immigrant
17		identification document, or any other actual or



1		purported government identification document, of
2		another person;
3	<u>(v)</u>	Committing extortion as defined by section 707-
4		<u>764;</u>
5	(vi)	Deception, as defined in section 708-800, or
6		fraud, which means falsely representing a present
7		or past fact, whether by words or conduct, or
8		failing to disclose a present or past fact that
9		causes a person to act, or fail to act, in
10		reliance thereon;
11	(vii)	Debt bondage;
12	(viii)	Causing or threatening to cause financial harm to
13		any person;
14	(ix)	Facilitating or controlling a person's access to
15		an addictive controlled substance; or
16	<u>(x)</u>	Using any scheme, plan, or pattern intended to
17		cause any person to believe that, if the person
18		did not perform the labor or services, that
19		person or another person would suffer serious
20		harm or physical restraint.
21	(b) Know	ingly recruiting, enticing, harboring,
22	tran	sporting, providing, or obtaining by any means

9	<u>(iii)</u>	Production of child pornography as defined in

11	(c) Traf	ficks another person for labor or services by

13	<u>(i)</u>	Recruiting, enticing, harboring, transporting,
14		providing, or obtaining by any means another
15		person, intending or knowing that the person will
16		be subjected to labor or services under paragraph
17		(a) or (b); or
18	<u>(ii)</u>	Benefiting, financially or by receiving anything
19		of value, from participation in a venture that
20		has engaged in an act involving labor or services
21		under paragraph (a) or (b); provided that this



1		subparagraph shall not apply to the person who is
2		trafficked.
3	(2)	A conviction and sentence for human trafficking shall
4	be in add	ition to, and not in lieu of, a conviction and sentence
5	for any underlying offense; provided that the sentence imposed	
6	under this section may run concurrent with or consecutive to the	
7	sentence for the underlying offense.	
8	(3)	In this section:
9	<u>(a)</u>	"Debt bondage" means the status or condition of a
10		debtor arising from a pledge by the debtor of the
11		debtor's personal services or those of a person under
12		the debtor's control as a security for debt, if the
13		value of those services as reasonably assessed is not
14		applied toward the liquidation of the debt or the
15		length and nature of those services are not
16		respectively limited and defined.
17	<u>(b)</u>	"Labor" means work of economic or financial value.
18	<u>(c)</u>	"Restraint" means to restrict a person's movement by
19		means of force as to interfere substantially with the
20		person's liberty.
21	<u>(d)</u>	"Services" means an ongoing relationship between a
22		person and the actor in which the person performs

1	activities under the supervision of or for the benefit
2	of the actor. Prostitution-related and obscenity-
3	related activities as set forth in chapter 712 are
4	forms of "services" under this section.
5	(4) Nothing in this section shall constitute a defense to
6	prostitution. It shall not be a defense to a charge under
7	subsection (1)(b) that the actor was mistaken as to the person's
8	age.
9	(5) Human trafficking under subsection (1)(a) is a class A
10	felony. Human trafficking under subsection (1)(b) is a class B
11	felony. Human trafficking under subsection (1)(c) is a class C
12	felony."
13	SECTION 2. Section 351-32, Hawaii Revised Statutes, is
14	amended to read as follows:
15	"\$351-32 Violent crimes. The crimes to which part III of
16	this chapter applies are the following and no other:
17	(1) Murder in the first degree (section 707-701);
18	(2) Murder in the second degree (section 707-701.5);
19	(3) Manslaughter (section 707-702);
20	(4) Negligent homicide in the first degree (section 707-
21	702.5);

3	(a)	All offenses which specifically authorize forfeiture;
4	(b)	Murder, kidnapping, <u>human trafficking,</u> gambling,
5		criminal property damage, robbery, bribery, extortion,
6		theft, unauthorized entry into motor vehicle,
7		burglary, money laundering, trademark counterfeiting,
8		insurance fraud, promoting a dangerous, harmful, or
9		detrimental drug, commercial promotion of marijuana,
10		unlawful methamphetamine trafficking, manufacturing of
11		a controlled substance with a child present, promoting
12		child abuse, or electronic enticement of a child which
13		is chargeable as a felony offense under state law;
14	(c)	The manufacture, sale, or distribution of a controlled
15		substance in violation of chapter 329, promoting
16		detrimental drugs or intoxicating compounds, promoting
17		pornography, promoting pornography for minors, or
18		promoting prostitution, which is chargeable as a
19		felony or misdemeanor offense, but not as a petty
20		misdemeanor, under state law; and



1	(d) The attempt, conspiracy, solicitation, coercion, or		
2	intimidation of another to commit any offense for		
3	which property is subject to forfeiture."		
4	SECTION 4. Section 842-1, Hawaii Revised Statutes, is		
5	amended by amending the definitions of "organized crime" and		
6	"racketeering activity" to read as follows:		
7	""Organized crime" means any combination or conspiracy to		
8	engage in criminal activity as a significant source of income or		
9	livelihood, or to violate, aid or abet the violation of criminal		
10	laws relating to prostitution, gambling, loan sharking, drug		
11	abuse, illegal drug distribution, counterfeiting, extortion,		
12	human trafficking, corruption of law enforcement officers or		
13	other public officers or employers.		
14	"Racketeering activity" means any act or threat involving,		
15	but not limited to murder, kidnapping, human trafficking,		
16	gambling, criminal property damage, robbery, bribery, extortion,		
17	theft or prostitution, or any dealing in narcotic or other		
18	dangerous drugs which is chargeable as a crime under state law		
19	and punishable by imprisonment for more than one year."		
20	SECTION 5. This Act does not affect rights and duties that		
21	matured, penalties that were incurred, and proceedings that were		
22	begun, before its effective date.



#### Report Title:

Human Trafficking; Forfeiture; Organized Crime

#### Description:

Creates the offense of human trafficking, adds human trafficking to the list of offenses addressed by the crime victim compensation commission, deletes involuntary servitude as part of unlawful imprisonment in the 1st degree, adds human trafficking as a covered offense for forfeitures, and adds human trafficking as an offense involving organized crime and racketeering activity.
