A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Over the years, many young Americans have had
their education interrupted or curtailed due to compulsory
induction into the military during times of conflict or war.
Others have had their schooling interrupted due to wartime
practices, such as the internment of Japanese and Japanese Americans during World War II.

7 The purpose of this Act is to direct the department of 8 education to establish a program to grant high school diplomas 9 to veterans of the armed services who could not complete their 10 high school education due to compulsory service in the armed 11 services of the United States during world war II, the Korean 12 conflict, and the Vietnam war, as well as those who did not 13 complete high school because of wartime practices.

SECTION 2. Chapter 302A, Hawaii Revised Statutes, is amended by adding a new section to part II to be appropriately designated and to read as follows:

17 "<u>\$302A-</u> Graduate equivalency diploma for armed services

18 veterans and others. (a) The department shall establish a
