A BILL FOR AN ACT

RELATING TO GAME MANAGEMENT AREAS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that introduced game 2 mammals are a significant threat to native species and
- 3 ecosystems, watersheds, public and private property, and human
- 4 health and safety.
- 5 The purpose of this Act is to protect public and private
- 6 land and resources from game mammals by requiring areas
- 7 maintained for commercial, public, or private hunting to be
- 8 fenced.
- 9 SECTION 2. Section 183D-4, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "\$183D-4 Game management areas, wildlife sanctuaries,
- 12 public hunting areas. (a) For the purposes of preserving,
- 13 protecting, conserving, and propagating wildlife, the department
- 14 shall establish, maintain, manage, and operate game management
- 15 areas, wildlife sanctuaries, and public hunting areas on land
- 16 under its control and, as it deems desirable, enter into
- 17 agreements for taking control of privately owned lands for those
- 18 purposes.
