A BILL FOR AN ACT

RELATING TO LAND ACQUISITION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. In its final report dated January 2006, the		
2	joint legislative housing and homeless task force expressed		
3	concern that the inventory of affordable housing rental units is		
4	at risk of being reduced. Affordable rental housing projects		
5	built in part with government subsidies have been offered for		
6	sale at market prices in anticipation of the expiration of		
7	income and regulatory restrictions encumbering the property.		
8	The task force is committed to ensuring that these units remain		
9	affordable to persons at lower income levels.		
10	In recent months, media reports have identified several		
11	affordable housing projects that may be offered for sale, such		
12	as the Kulana Nani apartments in Kaneohe, Oahu, that offer		
13	affordable rental housing.		
14	The legislature finds that:		
15	(1) Kulana Nani is a unique affordable housing resource in		
16	Kaneohe, Oahu, that provides low-income housing for		
17	working residents, senior citizens, and the disabled;		

1	(2)	Kulana Nani supports the character of the neighborhood	
2		serving as a primary source of workforce housing for	
3		Kaneohe residents;	
4	(3)	The affordable rental units in Kulana Nani are	
5		irreplaceable in the current housing market; and	
6	(4)	The residents, surrounding community, and Oahu as a	
7		whole would benefit from the active intervention of	
8		the State to ensure that there is no adverse effect on	
9		current and future residents of Kulana Nani.	
10	The	legislature therefore declares that the exercise of the	
11	power of	eminent domain to acquire the land under Kulana Nani is	
12	in the public interest and the acquisition is for a public use.		
13	The legislature further declares that it is necessary to provide		
14	for the public financing of the acquisition of the Kulana Nani		
15	property by condemnation through the expenditure of general		
16	funds and any available revenue bond proceeds and private funds		
17	at the disposal of the State.		
18	The	purpose of this Act is to preserve Kulana Nani as an	
19	affordable rental housing project.		
20	SECT	ION 2. The Hawaii housing finance and development	
21	corporati	on shall immediately initiate negotiations with	
22	Kamehameh	a Schools to ensure state acquisition of the Kulana

- 1 Nani property and may partner with a private developer for
- 2 acquisition of the property; provided that one hundred per cent
- 3 of the housing units on the property shall be retained in
- 4 perpetuity as affordable housing for households at or below the
- 5 income restrictions for rental housing units on the property as
- 6 of the effective date of this Act; provided further that if an
- 7 agreement to acquire the property is not reached within a
- 8 reasonable time, the Hawaii housing finance and development
- 9 corporation shall exercise its power of eminent domain to
- 10 acquire the property. For the purposes of this Act, and
- 11 notwithstanding any provision of section 201H-13, Hawaii Revised
- 12 Statutes, to the contrary, condemnation of the Kulana Nani
- 13 property shall not be subject to legislative disapproval.
- 14 The Hawaii housing finance and development corporation
- 15 shall submit a report to the legislature no later than twenty
- 16 days prior to the convening of the regular session of 2008
- 17 regarding its efforts to ensure acquisition of the Kulana Nani
- 18 property and its recommendations for financing the purchase of
- 19 the property.
- 20 SECTION 3. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$ or so much
- 22 thereof as may be necessary for fiscal year 2007-2008 for land
