## A BILL FOR AN ACT

RELATING TO PERSONS WITH DISABILITIES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The Hawaii Revised Statutes is amended by
2	adding a new section to be appropriately designated and to read
3	as follows:
4	"SA-A Baby changing stations. All state and county
5	restrooms available to the public with facilities for persons
6	with disabilities shall provide baby-changing stations pursuant
7	to rules adopted by the disability and communication access
8	board in accordance with chapter 91.
9	For the purposes of this section, "baby-changing station"
10	means an area that is designed to allow a person with
11	disabilities to change an infant's diaper and to generally care
12	for the infant.
13	Any required renovations of public restrooms required under
14	this section shall be completed by December 31, 2008."
15	SECTION 2. Section 103-50, Hawaii Revised Statutes, is
16	amended to read as follows:
17	"§103-50 Building design [ <del>to consider</del> ] <u>;</u> needs of persons
18	with disabilities. (a) Notwithstanding any other law to the

1	contrary, and except as provided in this section, all plans and
2	specifications for the construction of public buildings,
3	facilities, and sites shall be prepared so that the buildings,
4	facilities, and sites are accessible to and usable by persons
5	with disabilities. The buildings, facilities, and sites shall
6	conform to the Americans with Disabilities Act Accessibility
7	Guidelines, Title 36 Code of Federal Regulations Part 1191, and
8	the requirements of the Federal Fair Housing Amendments Act of
9	1988, as established in Title 24 Code of Federal Regulations
10	Part 100, Subpart D, as adopted and amended by the disability
11	and communication access board under chapter 348F.
12	(b) All plans and specifications for the construction of
13	public restrooms with facilities for disabled persons shall
14	provide baby changing stations as prescribed by rules adopted by
15	the disability and communications access board pursuant to
16	chapter 91.
17	"Baby changing station" has the same meaning as that term
18	is defined under section

20	section shall seek advice and recommendations from the
21	disability and communication access board on any construction
22	plans prior to commencing with construction.

1 SECTION 5. The sums appropriated by this Act shall be 2 expended by the department of accounting and general services 3 for the purposes of this Act. 4 SECTION 6. Statutory material to be repealed is bracketed 5 and stricken. New statutory material is underscored. 6 SECTION 7.
