A BILL FOR AN ACT

RELATING TO DEVELOPMENTAL DISABILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Developmental disabilities residential services
- 2 providers perform a vital service to the State by providing
- 3 important residential services to persons with developmental
- 4 disabilities or mental retardation.
- 5 The legislature enacted Act 168, Session Laws of Hawaii
- 6 2005, authorizing the department of health to make additional
- 7 payments for residential services to the providers of
- 8 developmental disabilities domiciliary homes and operators of
- 9 developmental disabilities apartment complexes.
- 10 Act 236, Session Laws of Hawaii 2005, appropriated \$485,000
- 11 of the \$1,600,000 of the requested appropriation for fiscal year
- 12 2005-2006 to implement Act 168. The amount appropriated was not
- 13 sufficient to meet the costs of operating the residential
- 14 settings on behalf of the State. The amount of the requested
- 15 appropriation for fiscal year 2006-2007 was \$1,798,200. Act
- 16 261, Session Laws of Hawaii 2006, appropriated \$1,200,000 for
- 17 fiscal year 2006-2007 to provide for the continued operation of

- 1 developmental disabilities domiciliary homes and apartment
- 2 complexes. Consequently, that amount remains insufficient to
- 3 continue operation of the residential services.
- 4 The purpose of this Act is to appropriate the necessary
- 5 funds in addition to the \$1,200,000 submitted in the department
- 6 of health's biennium budget request for the continued
- 7 maintenance and operation of developmental disabilities
- 8 domiciliary homes and apartment complexes for persons with
- 9 developmental disabilities.
- 10 SECTION 2. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$ or so much
- 12 thereof as may be necessary for fiscal year 2007-2008 and the
- 13 same sum or so much thereof as may be necessary for fiscal year
- 14 2008-2009 for continued operation of developmental disabilities
- 15 domiciliary homes and apartment complexes for persons with
- 16 developmental disabilities.
- 17 The sums appropriated shall be expended by the department
- 18 of health for the purposes of this Act.
- 19 SECTION 3. This Act shall take effect on July 1, 2020.
