### A BILL FOR AN ACT

RELATING TO CRIMINAL HISTORY RECORD CHECKS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 302A-601.5, Hawaii Revised Statutes, is 1 2 amended to read as follows: "[+]\$302A-601.5[<math>+] Employees of the department of 3 education [and teacher], providers, subcontractors, and trainees 4 from an institution of higher education in any public school; 5 6 criminal history record checks. (a) The department of education, including the Hawaii state public library system, 7 shall develop procedures for obtaining verifiable information 8 regarding the criminal history of persons who are employed or 9 seeking employment in any position[, including teacher]; persons 10 seeking to serve as providers or subcontractors; and trainees 11 12 from an institute of higher education that places them in close proximity to children. These procedures shall include criminal 13 history record checks conducted in accordance with section 846-14
- Information obtained pursuant to this subsection shall be
  used exclusively by the employer or prospective employer for the
  purpose of determining whether a person is suitable for working

4	SECTION 3. There is appropriated out of the general
5	revenues of the State of Hawaii the sum of \$112,000, or so much
6	thereof as may be necessary for fiscal year 2007-2008, and the
7	same sum, or so much thereof as may be necessary for fiscal year
8	2008-2009, for the department of education to conduct criminal
9	history record checks on providers, subcontractors, and trainees
10	from an institute of higher education who work and train in
11	close proximity to children.
12	SECTION 4. The sums appropriated shall be expended by the
13	department of education for the purposes of this Act.
14	SECTION 5. Statutory material to be repealed is bracketed
15	and stricken. New statutory material is underscored.
16	SECTION 6. This Act shall take effect on July 1, 2007.
