### A BILL FOR AN ACT

RELATING TO TATTOOING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 321, Hawaii Revised Statutes, is 2 amended by adding a new part to be appropriately designated and 3 to read as follows: 4 "PART HAWAIIAN TATTOO ARTISTS 5 §321-A Definitions. For the purposes of this chapter, 6 unless the context otherwise requires: 7 "Board" means the board of Hawaiian tattoo artists created 8 under this chapter. 9 "Ancient art of Hawaiian tattoo" means a procedure by which 10 an indelible mark or figure is fixed upon the body by insertion 11 of pigment under the skin or by production of scars, where the 12 basic procedures and equipment used are derived from ancient 13 Hawaiian tradition and practice. 14 "Hawaiian tattoo artist" means a person who practices the 15 ancient art of Hawaiian tattoo.
- 16 §321-B Board of Hawaiian tattoo artists; qualifications.
- 17 (a) There is established within the department of health for
- 18 administrative purposes a state board of Hawaiian tattoo artists

- 1 consisting of nine members. Five members of the board shall be
- 2 masters in the ancient art of Hawaiian tattoo as defined by
- 3 rule, and shall be appointed by the governor according to
- 4 criteria established by rule. Two members of the board shall be
- 5 public members appointed by the governor. The director of
- 6 health or the director's representative and the chairperson of
- 7 the school of Hawaiian studies of the University of Hawaii or
- 8 the chairperson's representative shall serve as ex officio non-
- 9 voting members.
- 10 (b) Except for members of the board first appointed and
- 11 the public and ex officio members of the board, no one shall be
- 12 eligible for appointment who does not at the time of the
- 13 member's appointment hold a valid and unexpired license to
- 14 practice as a Hawaiian tattoo artist.
- 15 §321-C Powers and duties of the board. (a) The board
- 16 shall adopt rules pursuant to chapter 91 for the purposes of
- 17 this chapter.
- (b) In addition to any other powers and duties authorized
- 19 by law, the board shall grant, or upon proof of violation of
- 20 this chapter or the rules adopted by the board governing the
- 21 practice under this chapter, revoke, suspend, or refuse to renew

- 4 (1) Hawaiian tattoo artist training requirements and other gualifications for licensure;
- 6 (2) Equipment, sanitation, and other operating standards
  7 for the practice of the ancient art of Hawaiian tattoo
  8 to protect the public health, which shall be adopted
  9 in consultation with the department of health; and
- 10 (3) Prohibited acts or practices of Hawaiian tattoo

  11 artists deemed by the board to be detrimental to the

  12 general public.
- (d) The board shall enforce this chapter and the rulesadopted under this chapter.

### 15 §321-D License required; application; physical

- 16 examination. (a) No person shall practice the ancient art of
- 17 Hawaiian tattoo without a current license issued pursuant to
- 18 this chapter.
- 19 (b) Any person who desires to practice the ancient art of
- 20 Hawaiian tattoo shall apply in writing to the board in the form
- 21 prescribed by the board.



1 (c) No license shall be issued unless the applicant has 2 undergone a physical examination using report forms provided by 3 the board. The examination shall include a chest x-ray or 4 tuberculin skin test, and a blood test for syphilis, and any 5 other test required by the board by rule. The physical 6 examination record shall be kept by the licensee as required by 7 the board by rule. 8 §321-E Fees. Any fees for application, licensing, and 9 other registrations shall be as provided in rules adopted by the 10 director of health pursuant to chapter 91. 11 §321-F **Restrictions.** (a) No Hawaiian tattoo artist shall 12 use the same bone needle to tattoo different persons. (b) No person with any disease or condition in a 13 14 communicable form or suspected of having such disease or 15 condition shall engage in the ancient art of Hawaiian tattoo. 16 Such disease or condition may include but shall not be limited 17 to: 18 (1)The common cold; 19 (2) Influenza; 20 Tuberculosis; (3)

- 7 SECTION 3. The department of health shall adopt rules
- 8 further defining the term "ancient art of Hawaiian tattoo" and
- 9 establishing criteria for the selection of masters in the
- 10 ancient art of Hawaiian tattoo. The rules adopted shall apply
- 11 only to the initial selection of the board of Hawaiian tattoo
- 12 artists under this Act. The board of Hawaiian tattoo artists
- 13 may by rule adopt, or amend and adopt the rules adopted by the
- 14 department of health under this section.
- 15 SECTION 4. This Act does not affect rights and duties that
- 16 matured, penalties that were incurred, and proceedings that were
- 17 begun, before its effective date.
- 18 SECTION 5. In codifying the new sections added by section
- 19 1 of this Act, the revisor of statutes shall substitute
- 20 appropriate section numbers for the letters used in designating
- 21 the new sections in this Act.
