### A BILL FOR AN ACT

RELATING TO EDUCATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the scope and level
2	of responsibilities of the board of education merits
3	compensation to its members based on a salary.
4	The purpose of this Act is to establish salaries for the
5	members of the board of education.
6	SECTION 2. Section 302A-1105, Hawaii Revised Statutes, is
7	amended to read as follows:
8	"§302A-1105 [Compensation;] Salaries; compensation;
9	<b>expenses.</b> (a) Board [ <del>of education</del> ] members shall [ <del>be allowed:</del> ]
10	receive an annual salary.
11	(b) Effective July 1, 2007, the annual salary of the
12	chairperson of the board shall be \$ and the annual
13	salary of all other board members shall be \$ .
14	(c) Any provision of law to the contrary notwithstanding,
15	all members of the board shall be included in any benefit
16	program generally applicable to officers and employees of the
17	State.

2	all members of the board shall be allowed:
3	[ <del>(1) Compensation at the rate of \$100 per day for each</del>

7	(3)] (2) Personal expenses at [the] rates specified by the
8	board while attending board meetings or while on
9	official business as authorized by the chairperson,
