## A BILL FOR AN ACT

RELATING TO THEFT.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 708-831, Hawaii Revised Statutes, is
2	amended to read as follows:	
3	"§70	8-831 Theft in the second degree. (1) A person
4	commits t	he offense of theft in the second degree if the person
5	commits t	heft:
6	(a)	Of property from the person of another;
7	(b)	Of property or services the value of which exceeds
8		\$300;
9	<u>(c)</u>	Of three or more items of mail belonging to three or
10		more unrelated persons in the same or separate
11		incident as part of a common scheme or plan;
12	[ <del>(c)</del> ]	(d) Of an aquacultural product or part thereof from
13		premises that is fenced or enclosed in a manner
14		designed to exclude intruders or there is prominently
15		displayed on the premises a sign or signs sufficient
16		to give notice and reading as follows: "Private
17		Property"; or

1 [<del>(d)</del>] (e) Of agricultural equipment, supplies, or products, 2 or part thereof, the value of which exceeds \$100 but 3 does not exceed \$20,000, or of agricultural products that exceed twenty-five pounds, from premises that are 4 fenced, enclosed, or secured in a manner designed to 5 6 exclude intruders or there is prominently displayed on 7 the premises a sign or signs sufficient to give notice 8 and reading as follows: "Private [Property."] 9 Property". The sign or signs, containing letters not less than two inches in height, shall be placed along 10 11 the boundary line of the land in a manner and in such 12 position as to be clearly noticeable from outside the boundary line. Possession of agricultural products 13 14 without ownership and movement certificates, when a certificate is required pursuant to chapter 145, is 15 16 prima facie evidence that the products are or have been stolen. 17

(2) Theft in the second degree is a class C felony. A person convicted of committing the offense of theft in the second degree under [+] subsection [(1)](c) and (d)] (1)(d) or (e) shall be sentenced in accordance with chapter 706, except that for the first offense, the court may impose a minimum

- 1 sentence of a fine of at least \$1,000 or [two-fold] twofold
- 2 damages sustained by the victim, whichever is greater."
- 3 SECTION 2. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were
- 5 begun, before its effective date.
- 6 SECTION 3. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 4. This Act shall take effect upon approval.

## Report Title:

Theft; Felony

## Description:

Provides that an individual caught with stolen mail belonging to three or more persons in the same or separate incident as part of a common scheme or plan commits second degree theft.
