# A BILL FOR AN ACT

RELATING TO PUBLIC HOUSING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Several years ago, when the federal Weed and 1 Seed initiative was in effect at the Mayor Wright homes public 2 housing complex, residents saw a significant change for the 3 better in their neighborhood. Recently, the complex has been 4 the site of a shooting and other disturbances involving tenants 5 and their neighbors. There have been several instances of 6 public drunkenness, excessive noise, and conflicts with 7 8 neighbors.

- 9 The purpose of this Act is to:
- 10 (1) Appropriate funds for improved security measures at
  11 the Mayor Wright homes public housing complex,
  12 including the contract hiring of at least three
  13 security officers; and
  14 (2) Require the Hawaii public housing authority to submit
  15 a report to the legislature on the progress of
- 16 security improvements at Mayor Wright homes.

prior to the convening of the 2008 regular session on the 1 2 progress of security improvements at Mayor Wright homes. The report shall include: 3 Steps that have been taken to improve the safety and 4 (1)security of the residents of Mayor Wright homes; 5 (2)Plans made with the management of Mayor Wright homes, 6 tenants, and other stakeholders to further improve 7 security; 8 The amount of additional security guards required to 9 (3) 10 ensure the safety of the tenants and guests of Mayor Wright homes on a twenty-four-hour basis; and 11 Any other findings and recommendations, including 12 (4) suggested legislation, regarding the security 13 14 situation at Mayor Wright homes. There is appropriated out of the general 15 SECTION 3. revenues of the State of Hawaii the sum of \$ 16 or so much thereof as may be necessary for fiscal year 2007-2008 and the 17 18 same sum or so much thereof as may be necessary for fiscal year 19 2008-2009 for the contract hiring of at least three full-time security officers at Mayor Wright homes public housing complex. 20
