## A BILL FOR AN ACT

RELATING TO DENTAL CARE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. In 2006, the legislature appropriated funds to
2	the department of human services to restore specific preventive
3	and restorative dental services for eligible persons twenty-one
4	years-of-age or older under the State's medicaid and QUEST
5	programs. Previously, dental coverage for eligible adults was
6	limited to dental emergencies. According to a recent department
7	of health report, each eligible adult can receive specific
8	preventive and restorative services, including dentures,
9	equivalent to \$500. However, this does not include coverage for
10	endodontic care, root canals, crowns, elective procedures, or
11	periodontal surgery. Also, partial and full dentures generally
12	cost more than \$500.
13	The purpose of this Act is to:
14	(1) Expand coverage under medicaid and QUEST to include
15	comprehensive dental care coverage for eligible
16	persons twenty-one years-of-age or older and to

1 appropriate funds to provide the additional coverage; 2 and 3 Appropriate funds for hospital dentistry for the (2) 4 developmentally disabled in the county of Hawaii. 5 SECTION 2. Chapter 346, Hawaii Revised Statutes, is 6 amended by adding a new section to be appropriately designated 7 and to read as follows: 8 Dental care coverage. The department shall "§346-9 provide comprehensive coverage to medicaid and QUEST recipients 10 for dental care administered by licensed practitioners under 11 chapters 447 and 448. 12 The department shall administer this benefit in a manner 13 that meets federal requirements that are a condition of the 14 receipt of federal funds by the State. 15 For purposes of this section, "comprehensive coverage" 16 means the dental benefit as defined in the Hawaii state plan for **17** medicaid." 18 SECTION 3. There is appropriated out of the general 19 revenues of the State of Hawaii the sum of \$ or so much 20 thereof as may be necessary for fiscal year 2007-2008 and the 21 same sum or so much thereof as may be necessary for fiscal year 22 2008-2009 to expand coverage under medicaid and QUEST to include

- 1 comprehensive dental care coverage for persons twenty-one years

- 3 The sums appropriated shall be expended by the department

- 5 SECTION 4. There is appropriated out of the general
