## A BILL FOR AN ACT

RELATING TO CHILDREN.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. (a) The chair of the senate committee on human		
2	services and public housing and the chair of the house of		
3	representatives committee on human services shall convene a		
4	temporary statewide task force on system responses to cases of		
5	child sexual assault and exploitation. The purpose of the task		
6	force shall be to review, assess, and make recommendations on		
7	Hawaii's system responses to cases regarding:		
8	(1) Child sexual abuse, assault, and exploitation;		
9	(2) Sexually reactive children;		
10	(3) Youth who sexually offend; and		
11	(4) Related minor-to-minor incest.		
12	The task force shall also consider associated issues, including		
13	Internet crimes against children, child pornography, and child		
14	trafficking in its discussions.		
15	(b) In addition to the co-convenors, as specified under

3 SECTION 2. The statewide task force on system responses to 4 cases of child sexual assault and exploitation shall submit an 5 interim report of its findings and recommendations, including any proposed legislation, to the legislature no later than 6 7 twenty days prior to the convening of the regular session of 8 2008, and a final report of its findings and recommendations, 9 including any proposed legislation, to the legislature no later 10 than twenty days prior to the convening of the regular session 11 of 2009. The advisory task force shall cease to exist on 12 June 30, 2009.

SECTION 3. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ , or so much thereof as may be necessary for fiscal year 2007-2008, and the same sum, or so much thereof as may be necessary for fiscal year 2008-2009, for the statewide task force on system responses to cases of child sexual assault and exploitation.

19 The sums appropriated shall be expended by the senate for20 the purposes of this Act.

21SECTION 4. There is appropriated out of the general22revenues of the State of Hawaii the sum of \$ , or so



1 much thereof as may be necessary for fiscal year 2007-2008, and 2 the same sum, or so much thereof as may be necessary for fiscal 3 year 2008-2009, for the statewide task force on system responses 4 to cases of child sexual assault and exploitation. The sums appropriated shall be expended by the house of 5 6 representatives for the purposes of this Act. 7 SECTION 5. This Act shall take effect upon approval; 8 provided that sections 3 and 4 shall take effect on 9 July 1, 2007.
