A BILL FOR AN ACT

RELATING TO CHILDREN.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. (a) The chair of the senate committee on human 2 services and public housing and the chair of the house of 3 representatives committee on human services and housing shall convene a temporary statewide task force on system responses to 4 5 cases of child sexual assault and exploitation. The purpose of 6 the task force shall be to review, assess, and make 7 recommendations for Hawaii's system responses to cases 8 regarding: 9 (1) Child sexual abuse, assault, and exploitation; **10** (2) Sexually reactive children; 11 (3) Youth who sexually offend; and (4) Related minor-to-minor incest. 12 13 The task force shall also consider associated issues, including 14 Internet crimes against children, child pornography, and child 15 trafficking in its discussions.
